A&M Part of Multi-School Consortium on Data Science

Alabama A&M University is part of a HBCU consortium offered seed funding from the National Science Foundation.

Headed by Johnson C. Smith University in Charlotte, N.C., the HBCU Data Science Consortium will work with faculty from AAMU, Bowie State University, Florida A&M University, Morehouse College and Norfolk State University to address the underrepresentation of African Americans in the field data science. The NSF awarded a \$100,000 seed grant for the development and implementation of the

consortium.

An inaugural workshop, "HBCU Data Science Consortium—Building Data Science Pillars," is scheduled to take place virtually Feb. 19-20.

"Johnson C. Smith and several other HBCUs have been working to address this need by providing students across the nation with high-demand data skills," said Felesia Stukes, assistant professor of computer science at JCSs. The Consortium is an exciting way to build a diverse community of practice that could help accelerate and expand our reach."

What We Know about the New COVID-19 Variant

Just as vaccines are rolling out for the current COVID-19 virus that are roughly 94% effective, a new variation of the disease has surfaced.

The United Kingdom has identified a new, potentially more contagious coronavirus variant linked to a recent surge in cases in England.

The new variant is being called VUI-202012/01 — the first "Variant Under Investigation" in the UK in December 2020.

Some are saying it reacts more quickly upon contact and others are saying that it's more contagious than the current virus we know most about.

The UK government's New and Emerging Respiratory Virus Threats Advisory Group said it had "moderate confidence" that this new variant "demonstrates a substantial increase in transmissibility compared to other variants."

Chris Whitty, England's chief medical officer, said this particular variant "contains 23 different changes."

To better understand what this is, we need to comprehend what a variant is.

It's not uncommon or unusual to see multiple strains of the same virus. For example, swine flu viruses do not normally infect humans. However, sporadic human infections with influenza viruses that normally circulate in swine and not people have occurred. When this happens, these viruses are called "variant viruses." They also can be denoted by adding the letter "v" to the end of the virus subtype designation.

However, this virus is slightly different. The vari-

ant carries a set of mutations including an N501Y mutation to part of the genetic sequence which forms the spike protein.

"There is still much we don't know. While we are fairly certain the variant is transmitted more quickly, there is no evidence to suggest that it is more lethal or causes more severe illness. Equally, there is no evidence to suggest the vaccine will be any less effective against the new variant," United Kingdom Prime Minister Boris Johnson said.

Public Health England says it is working to learn as much about the variant as possible.

The British variant has about 20 mutations, including several that affect how the virus locks onto human cells and infects them.

These mutations may allow

the variant to replicate and transmit more efficiently, said Muge Cevik, an infectious disease expert at the University of St. Andrews in Scotland.

European Union members Austria, Belgium, Bulgaria, France, Germany, Ireland, Italy, and the Netherlands announced travel restrictions hours after Johnson's speech.

The variant can be found across the UK, except
Northern Ireland, but it is heavily concentrated in
London, the South East, and eastern England. Cases elsewhere in the country do not seem to have taken off ...
In short: It will be very hard for the coronavirus to escape the body's defenses, despite the many variations it may adopt.

Surviving the New Year: A Nutritionist's Perspective

Sure, we're surrounded by temptation, like yummy treats, all year long. But, there's something about the holiday season that increases our urge to dive deep into an abyss of banana pudding, fill up on peach cobbler or say "YAAAS" to just one more helping of grandma's sweet potato pie.

Needless to say, while sweet swaps or avoiding them altogether sounds nice, that may not be your best course of action when trying to stay on course.

In case you didn't know so, holiday weight gain is real! In fact, according to research from Cornell University's Food and Brand Lab as well as scientists in Finland and France, Americans were found to experience weight gain throughout October and November, and peaked 10 days after Christmas. Although the change wasn't large — about 1.3 pounds during the Christmas to

New Year's season - the extra pounds can take up to five months to lose.

What You Can Do

"Switches are still junk. Fuel yourself throughout the day and go into every situation feeling satisfied and in control," Adrienne Daly, a lifestyle nutrition coach, tells BlackDoctor. org.

"I encourage my nutrition coaching clients not to save themselves for the party foods and drink, but to eat normally through the day and to meal prep," added Daly.

By eating meals that are low in carbs and high in veggies and healthy fats, Daly went on to argue that "this keeps down the crave/ dive into food and drink head first feelings we all have during the holidays."

Alternate drinks. Festive cocktails are super fun. They are also super caloric. Instead, reach for soda on the rocks with a splash of



cranberry or lime juice for a punch of flavor. "Alternate with an alcoholic beverage of choice," continued Daly.

Snack smart. "Snack on the meat and veggie selections only — keeping sugar at bay."

Don't be impulsive.

Reaching for every dish you see is a big "no, no." Said Daly: "It's just food. Think of every bite as 5g of FAT. Because it is. Pass it by!"

DO NOT SKIP THE GYM.

Be Mindful. "Find a mantra that means something to you, religion or

spiritually based. Speak to whatever aligns with your core values for change and personal strength," said Daly, reminding us that often our struggles with cravings is mental, not physical.

Example: "I am working harder than anyone else in this room to keep my waist tight, and with your love

and support, Lord, I can have success."

"It works and my clients have a great feeling of control and satisfaction, especially when they wake up the next day feeling accomplished and not shameful," Daly concluded.



HBCU graduate;


"Black Greek"; and California Democrat!

Here are the happenings in Washington, D.C., this week:

1. ON THE FLOOR.

The House reconvened Monday and was expected to vote on an override (2/3rds vote required) of President Trump's veto of the \$740 billion Defense Authorization bill and to hold a separate vote

to amend the \$2.3 trillion combined FY 2021 omnibus appropriations package/COVID relief bill – signed by the President Sunday night – to raise direct COVID relief payments from \$600 to \$2,000, at the President's urging. The Senate was scheduled to reconvene on Tuesday to take up the Defense bill override (but only if the

House succeeded in its override vote). In his signing statement Sunday night on the appropriations/COVID bill, the President said that the Senate "will start the process for a vote that increases checks to \$2,000, repeals Section

230 [of the Communications Decency Act], and starts an investigation into voter fraud."

2. BIDEN TRANSITION NEWS.

This week, Presidentelect Biden is expected to make more announcements on cabinet appointees, such as Attorney General, Commerce Secretary, Labor Secretary, and CIA Director. Last week, the Biden/Harris team announced Connecticut's Commissioner of Education Miguel Cardona as the nominee for Secretary of Education.

On December 23, Transportation Secretarydesignee Pete Buttigieg met with the following group of mayors to discuss the critical need for transportation and infrastructure investment:

3. CORONAVIRUS VACCINE.

According to the U.S. Centers for Disease Control, 1,944,585 people in the U.S. have received their first dose of the Moderna and Pfizer BioNTech COVID vaccines as of December 26 and 9,547,925 doses have been distributed.

On December 23, the Trump Administration announced that it will purchase an additional 100 million doses of COV-ID-19 vaccine from Pfizer, with 70 million doses to be delivered by June 30, 2021, and the remaining 30 million doses to be delivered no later than July 31, 2021 (bringing the total U.S.

purchase to 200 million doses).


