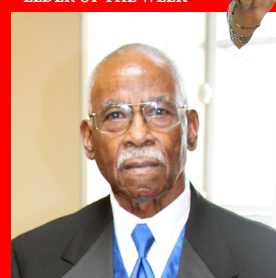

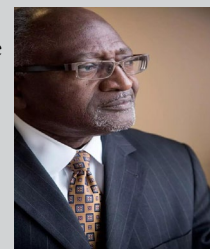

Dr. Bullard is an Alabamian and graduate of AAMU who has become a legend in the

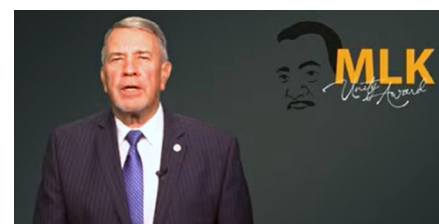
field of environmental justice over the course of his extensive tenure at Texas Southern University.

Alphas Hold 37th MLK Breakfast Virtually, Give Honors

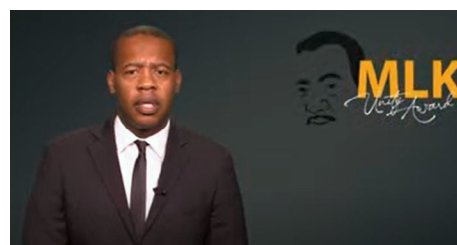

Washington in One Minute



Here are the happenings in Washington, D.C., this week:

1. **ON THE FLOOR.** The House and Senate are in session this week. The Senate canceled its scheduled recess this week to take up a House-passed package that includes the Freedom to Vote Act and the John Lewis Voting Rights Act — the first of which expands access to the ballot and shields election officials; the second restores key sections of the 1965 Voting Rights Act. Senate Majority Leader Chuck Schumer (D-NY) announced on Friday that if GOP Senators block passage of the bill, he will hold a vote to change the Senate's filibuster rule, which would require all Democrats voting "aye" to pass.

2. **THE WHITE HOUSE.** On Wednesday afternoon, President Biden held a press conference at the White House to mark his one year in office. On Friday, he will give a speech at the

Capital Hilton at the U.S. Conference of Mayors' 90th Annual Winter Meeting in D.C. On Wednesday, the Biden Administration's new COVID-19 test ordering site went live and allows Americans to order 4 free at-home COVID-19 tests per household — which will be shipped out 7-12 days after they have been ordered. The site is: www.covidtests.gov.

3. **THE SUPREME COURT.** On Wednesday, the Supreme Court heard arguments in Federal Election Commission v. Ted Cruz for Senate, where it considered whether a law that prevents candidates for federal office from using more than \$250,000 in campaign funds raised after an election to repay their personal loans to a campaign violates the Free Speech Clause of the First Amendment. Last Thursday, the Court issued 2 unsigned orders, the first of which blocked implementation of the Biden Administration's

vaccine-or-test mandate for employers with 100 or more workers, while litigation over its legality continues in the U.S. Court of Appeals for the 6th Circuit, saying that the Administration had exceeded its authority. The 2nd order allowed the vaccine mandate for health care workers at facilities that participate in the Medicare and Medicaid programs to go forward.

4. **FISCAL YEAR 2022 APPROPRIATIONS.** Last Thursday, the 2 Chairs and 2 Ranking GOP Members of the House and Senate Appropriations Committee held a so-called "Four Corners" meeting to discuss the status of the Fiscal Year 2022 appropriations bills. Currently, none of the 12 annual Fiscal Year 2022 appropriations bills have been enacted and the federal government is operating under a continuing resolution that is funding programs at Fiscal Year 2021 levels through Feb. 18, 2022. After the meeting, House and Senate Chairs Leahy and DeLauro issued a statement that they would "look forward to further conversations in the coming days, with the shared goal of finishing [their] work by the February 18 government funding deadline."

5. **DC VACCINE RULE.** Last Saturday (Jan. 15), a new rule went into effect in Washington, D.C., that requires

all persons 12 years and old entering indoor public spaces to show proof of having had at least 1 COVID vaccination shot. DC also requires masks for indoor spaces.

6. **WILLIE O'REE GOLD MEDAL:** This week the House will consider S.492, the Willie O'Ree Congressional Gold Medal Act, under suspension. The Senate passed legislation would award a Congressional Gold Medal to Hockey Hall of Fame member Willie O'Ree in recognition of his extraordinary contributions and commitment to hockey,

inclusion, and recreational opportunity. Mr. O'Ree was known as the "Jackie Robinson of Hockey" and made his NHL debut for the Boston Bruins on January 18, 1958. He played Professional hockey for 22 years, despite being blind in one eye.

lated as *Adonai*, which is equivalent to ruler or master. So, if these things are ruling over your lives, then you have entered a dangerous place that is not God's will for your life.

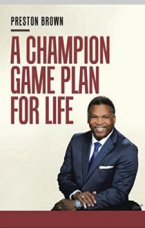
Anytime our will becomes greater than God's will for our lives, it will eventually end in separation from God. That's why it is important that we seek Him first so things don't get out of hand.

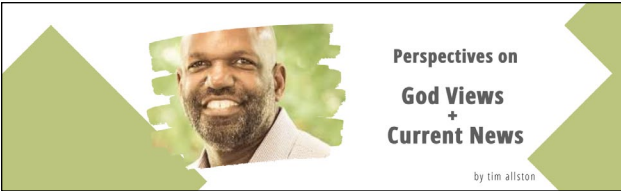

Remembering Sidney Poitier's
Starring Role: Silver-Mettle Leader



Before there was the first African-American to win an Oscar as the lead actor (Denzel Washington, 2002) there was the first African-American to win an Oscar in a supporting role (Sidney Poitier, 1964), who died on January 7 at age 94.

In addition to his acting trailblazing and civil rights activism, Poitier's legacy is also an example of silver-mettle leadership (SML).

Silver-mettle "leaders from the middle" are persons in number two positions that every organization must have to survive and thrive. Although they possess top leadership skills and experiences, often SMLs must step back and allow Time and Circumstances to elevate them.

With only a fourth-grade education, trouble reading three-syllable words, and a strong native Bahamian accent, 16-year old Poitier came to New York City as a dishwasher. He answered an "Actors Needed" ad from the American Negro Theater, was rejected, but took its janitorial job in exchange for further study. It paid off.

Although rejected a second time for showing "a lack of possibility," his fellow students petitioned the theater company to give Poitier a role in an upcoming play, as an understudy to a handsome and good actor who "could sing a little," he recalled.

When Lysistrata's opening night arrived and the lead actor could not make it, the prepared Poitier was elevated. And the rest became history, . . .

Oh, that handsome no-show lead actor became Poitier's longtime friend and civil rights co-activist, Harry Belafonte.

Do you aspire to Poitier-like greatness? Then, imitate his process and follow Jesus' words, "He that is greatest among you let him be your servant," Matthew 23:11.

Drake President to Represent ACCS on State Board

Comfortable or Conformable

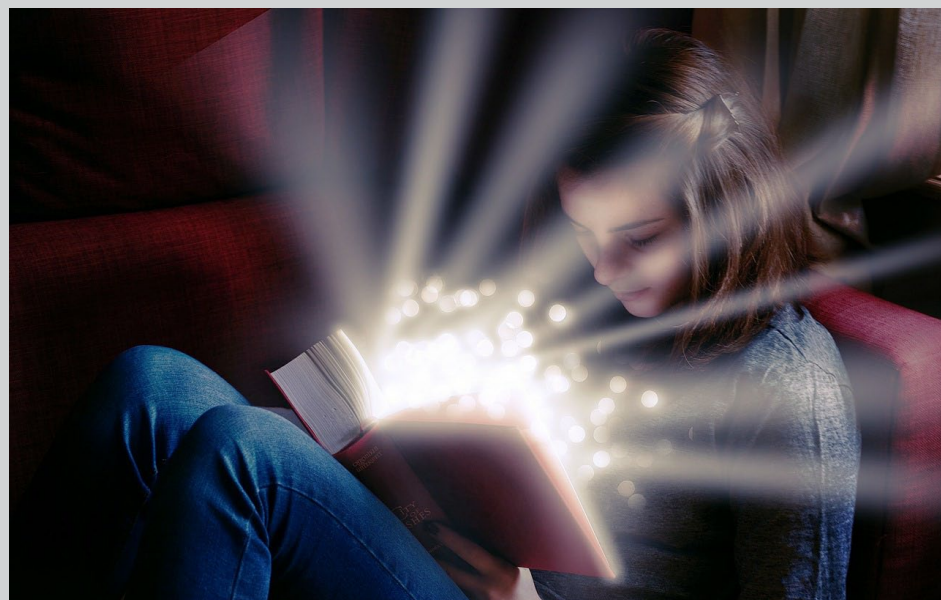
Romans 8:28-29

All of us like to be comfortable. That is why we are very intentional about our furniture, bedding, clothing and shoes. When either of those items is not “comfortable,” the experience is quite “uncomfortable.” The desire and design for comfort when it comes to those aforementioned items are understandable and logical. However when

it comes to God’s goal for His children, it is not to make us *comfortable*, but rather to make us *conformable*. The *how* and *why* are both under the purview of His providence. The Apostle Paul does give us some insight into what God uses in the process of making us conformable; **all things**. Romans 8:28 gets quoted quite often, especially when life seems to be spinning out of control. *All things*

work together for good...

The import of that verse is even better understood in the NLT translation, which reads, *And we know that God causes (my emphasis) all things to work together for the good of those who love God...*

about making life *comfortable, couchy, and cushiony*. The truth of the matter; He is conforming us to the image of His Son. Praise God!

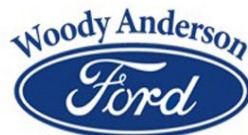

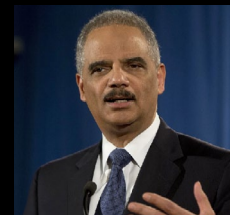

A mixed-use development will break ground in Cummings Research Park this spring, likely the first project in the park's east sector. It will feature office and retail space, as well as 251 apartment units, according to al.com.

It will be built on the former site of John Paul II Catholic High School.



Earlier this month, crews began demolition on the building that once housed the high school as well as other tenants.

The development will

include 12,000 square feet of office space and 7,000 square feet of retail space in addition to the apartment units.

Putting a Ring on It: A&M Scientists Monitor Tremor

Perhaps you have been thinking about a loved one or friend impacted by multiple sclerosis or Parkinson's disease. Then, knowing that a local and caring group of researchers is thinking about them, too, likely will brighten your day.

An industrious materials sciences group at Alabama A&M University is developing a biomedical sensor that will monitor the severity of hand tremor.

The group, led by Dr. Ashok K. Batra, has published its work in a recent journal, *Sensors & Transducers*.

In addition to AAMU, the impactful team has pulled in researchers from the International Clean Water Institute of Manassas, Va.; Riga Technical University in Latvia; and the Henry Ford Health System in Detroit,

Mich.

Batra and associates define tremor as "a small, rhythmic shaking movement that occurs in a back-and-forth pattern" that is common at some scale in everyone, although usually undetectable. Added factors, such as fatigue, stress, fear, anger—or even caffeine—



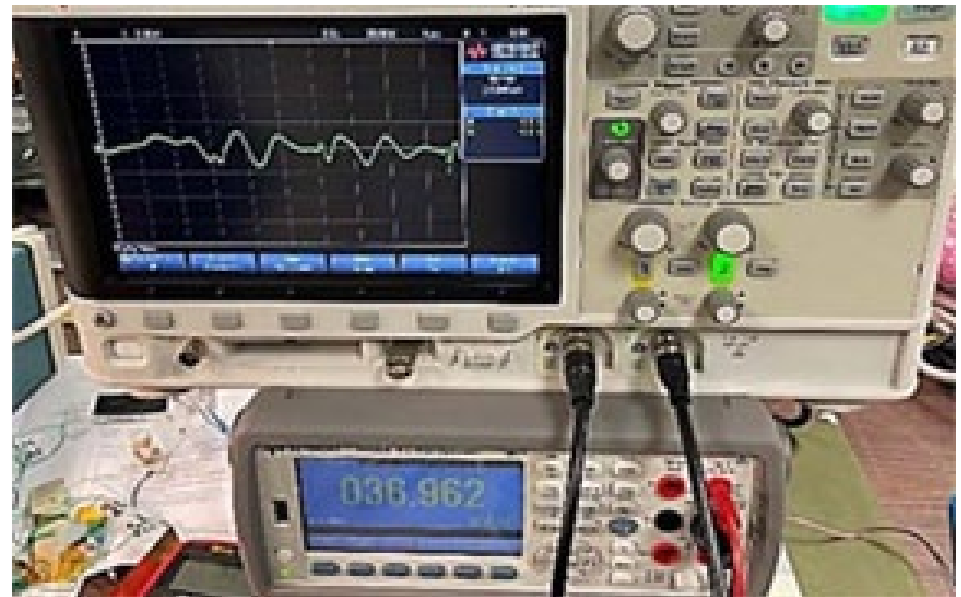
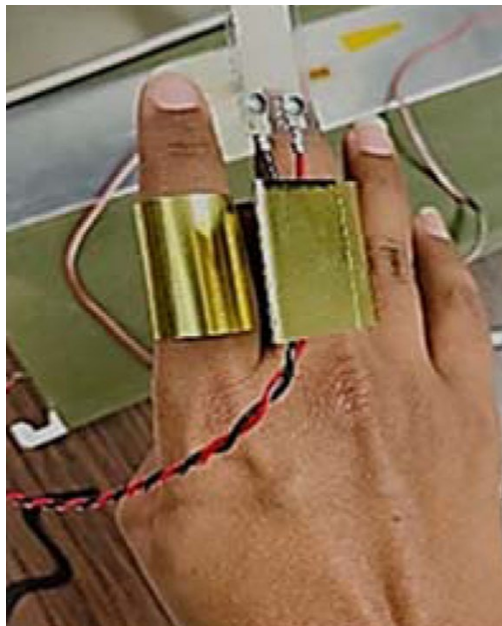
can make the tremor more obvious.

The team, however, focused on hand tremor

most common among middle-aged and older persons.

The team developed a light-weight ring out of special material and tested it as a potential means of monitoring hand tremor.

The researchers are hopeful further clinical investigations can be useful in a home environment, opening the door for a home-monitoring system similar to ones used



to monitor blood pressure.

The article is published in Vol. 253, Issue 6, of *Sensors & Transducers*.
