We celebrate another milestone in Huntsville's storied success. Under the Saturn V rocket at the U.S. Space and Rocket Center, I joined the CEO of Huntsville Utilities and the Director of Expansion for Google Fiber in announcing that Huntsville will be a Gig City, thanks to a unique model that may well serve as a new municipal standard.

Huntsville Utilities will be constructing a massive new fiber network to serve our city's growing data needs, and that network will provide something else--extra room for broadband service providers to offer our citizens ultra-high speed Internet at competitive prices.

Google Fiber is coming to Huntsville and will be using part of the municipal fiber network to bring gigabit Internet to businesses and residents.

In the near future, our citizens will have access to the highest

broadband speed available on the planet.

We already know Huntsville is a place where people do cool things, smart things, things that change the world. A rocket city deserves rocket speed, and that means a network that connects to the Internet at 1 gigabit per second. Your Internet will be 50 to 100 times faster than it is today.

One thing is certain. We're working every day to give every corner of Huntsville the best opportunities possible--the best jobs, the best quality of life, the best education, the best future.

We are the smart city that looks far beyond what we can see, and instead looks at what we can do. Our vision is bold. Our plan is solid. Our possibilities are endless. Thank you, Huntsville Utilities. Welcome, Google Fiber. And, to our citizens, prepare for lift off and ultra-high speed Internet connectivity.

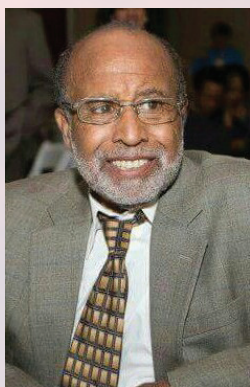

What You Need to Do with Your Form 1095-B

This year, you may receive one or more forms that provide information about the health coverage you had in 2015. These forms are 1095-A, 1095-B and 1095-C.

Form 1095-B, Health Coverage, provides you with information about your health care coverage if you, your spouse or your dependents enrolled in coverage through an insurance provider or self-insured employer last year. Here are the answers to questions regarding Form 1095-B:

Will I get a Form 1095-B?

- You will receive Form 1095-B - which is a new form this year - from your insurance provider if you had insurance for you or your family members.

- The term "health insurance providers" includes insurance companies, some self-insured employers, and government agencies that run Medicare, Medicaid or CHIP.

- You are likely to get more than one form if:
 - You had coverage from more than one provider
 - You changed coverage or employers during the year, or if different members of your family received coverage from different providers

How do I use the information on my Form 1095-B?

- This form provides information about your health coverage, including who was covered, and when the coverage was in effect.
- If Form 1095-B, Part IV,

Column (d), shows coverage for you and everyone in your family for the entire year; you can simply check the full-year coverage box on your tax return.

- If you did not have coverage for the entire year, use Form 1095-B, Part IV, Column (e), to determine the months when you or your family members had coverage. If there were months that you did not

have coverage, you should determine if you qualify for an exemption from the requirement to have coverage. If not, you must make an individual shared responsibility payment.

- You are not required to file a tax return solely because you received a Form 1095-B if you are otherwise not required to file a tax return.
- Do not attach Form

1095-B to your tax return - keep it with your tax records.

What if I don't get my Form 1095-B?

- You might not receive a Form 1095-B by the time you are ready to file your 2015 tax return, and it is not necessary to wait for it to file.
- The information on these forms may assist in preparing a return, and you,

however, can prepare and file your return using other information about your health insurance.

- The IRS does not issue and cannot provide you with your Form 1095-B. For questions about your Form 1095-B, contact the coverage provider. See line 18 of the Form 1095-B for a contact number.

Depending upon your circumstances, you might also receive Forms 1095-A and 1095-C.

Rosetta James Foundation "Honoring Our Elders" Banquet March 12

Seven distinguished local men and women will be honored at the Tenth Annual Rosetta James "Honoring Our Elders" Celebration scheduled at 5 p.m. Saturday, March 12, 2016, at The Jackson Center, located at 6001 Moquin Drive NW in Cummings Research Park.

Named in honor of a local, long-time activist, volunteer and civil rights advocate, the Rosetta James Foundation recognizes individuals 70 years of age and over who have given consistently, unselfishly and untiringly of themselves in service to mankind, worthwhile causes and institutions.

Comprising the 2016 honorees are: **Dr. Marvin Carroll**, president and CEO of Tec-Masters, Inc.; **Mother Betty Craighead**, former hospital staffer and senior advocate; **Mr. James D. Foster**, retired civilian personnel administrator; **Mr. Freeman Holifield**, former police officer and retired supervisory instructional/educational systems specialist; **Mrs. Janie Holifield**, retired educator and active alumna; **Mrs. Jacqueline Reed**, long-time community activist and columnist; and the **Hon. Richard D. Showers, Sr.**, educator and Huntsville City Councilman.

Dr. Marvin P. Carroll is not only known for his phenomenal entrepreneurial skills, but the Howard University graduate has often been dubbed as a "servant leader" who embodies generosity, humility and service. Dr. Carroll has a long giving history to colleges, universities, civic and community organizations, non-profit



organizations, public and private schools, and individuals. He is a philanthropist who believes in supporting the mission statements and goals of the various constituent groups, as well as the potential of prospective young leaders unknown to him.

Mother Betty Joyce Ford Craighead amassed decades in the hospital and medical insurance fields, starting out as a unit secretary at Huntsville Hospital in 1965 and ultimately retiring from Humana as a customer service supervisor in 1996. She has also served in numerous positions at Union Chapel Missionary Baptist Church, ranging from the Stitching and Quilting Ministry to the Superintendent of Sunday School. Well-travelled, Mother Craighead has ably taken a lead role in several community service projects.



Mr. James D. Foster (James d foster) retired after nearly 40 years of federal government service, primarily in civilian personnel administration. The Birmingham native is the recipient of legions of awards for his contributions and expertise in his professional work environment,

the community, civic groups and other membership organizations, among them Blacks in Government. His two-year Army assignments were based in Europe and Vietnam. He has played an active role in the



support of the Huntsville Tennis Center, the women's athletic program at Alabama A&M University, and the Vestry at Holy Cross-St. Christopher's Episcopal Church, where he serves as treasurer and acting junior warden. He is also Past Polemarch of the Huntsville Alumni Chapter of Kappa Alpha Psi Fraternity, Inc.

Mr. Freeman Holifield, Sr., is a retired supervisory instructional/educational systems specialist from the U.S. Missile Munitions Center and School at Redstone Arsenal. Holifield and a cadre of friends from Alabama A&M University garnered the community support that led to the successful integration of the Huntsville Police Department in 1963. Moreover, his gift for mediation was an asset state-side and abroad when he left



the police department for a 33-year career with the federal government. A life member of Omega Psi Phi Fraternity, Inc., and Ancient Egyptian Arabic Nobles of Mystic Shrine, Holifield is an avid supporter of AAMU athletics and alumni initiatives.

Mrs. Janie Adams Holifield is a retired educator who began her career as a first grade teacher at W.C. Handy Elementary School in Florence, Ala., where she also doubled as a librarian for two years. In the late 1970s, she became the first African-American assistant principal



at Gurley High School in Madison County, Ala. From 1971-74 and from 1980-83, she taught as an elementary school teacher in Germany. Over the years, she has been a long-time and proud supporter of Alabama A&M University and First Missionary Baptist Church. She is a Past Illustrious Commandress and Past Imperial Deputy of Egyptian Parade of Stars, as well as a past member of the Order of Eastern Star, Mizpah Chapter #37 and the Golden Circle.

Mrs. Jacqueline "Jackie" Reed is a long-time community activist and advocate who has devoted considerable time to ensuring that the political atmosphere of Huntsville remains fair, balanced and void of "the good old boy club"—even if doing so has meant that she has had to run for mayor and council seats herself. For years, she also has been a consistent contributor to "One Woman's Opinion," a regular column in Speakin' Out



News.

Hon. Richard Showers, Sr., was first elected to the Huntsville City Council in 1988, and he has served as a basic career education teacher for the Huntsville Center of Technology. Showers has earned B.S. and M.S. degrees from AAMU in agribusiness and trade/industrial education, respectively. Showers has served on numerous planning commissions and boards that are instrumental to the successful growth and development of Huntsville. These boards

include: Planning Commission, Metropolitan Planning Committee, Clean Community Committee, Historical Preservation Authority, Zoning Subcommittee, and the Local Emergency Planning Committee and the Top of Alabama Regional Council of Governments. He is the recipient of many awards and citations for his lifelong service.

The Rosetta James Foundation will also honor two additional individuals for significant career achievements. The recipients of the Foundation's "Pioneer Award" for 2016 will be: **Mrs. Dorothy Davidson**, noted mathematician and philanthropist, and **Rev. Dr. Julius R. that's schooling, training, or experience, we all have to learn how things work.

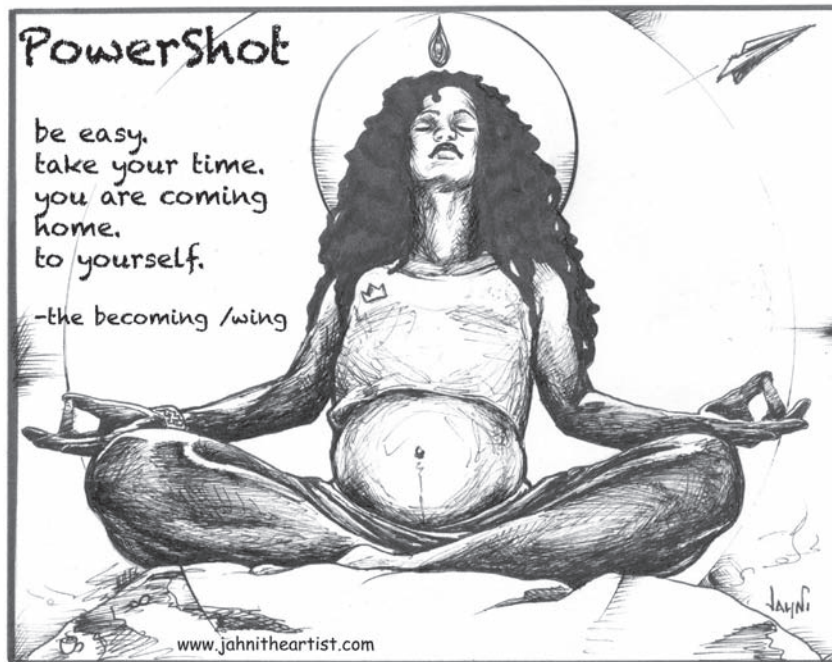

This Week in Washington

Here are the top issues in Washington this week:

1. The House and Senate are in session this week. The House, among other bills, will take up a bill to reform the Federal Advisory Committee process, which has been the subject of much controversy over the years, because of the federal government's heavy reliance on the approximately 1,000 committees (and their 64,000 members) across the government, which often appoint industry executives and other insiders to advise on setting policy and creating new regulations. President Obama made news when he banned lobbyists from the committees in 2010, only to pull back on the ban slightly in 2014 when forced to do so by court order. The House will also vote on a bill to reauthorize the Federal Emergency Management Agency (FEMA), including language which will significantly limit FEMA's ability to reclaim funds--to 3 years--when FEMA's eligibility rules change and the agency tries to take back the money. Lastly, the House will vote on a bill to prohibit federal payments for nonemergency services from providers that no longer participate in Medicaid, Medicare or the Children's Health Insurance Program (CHIP) and a bill to exempt the brick-making industry from having to comply with Clean Air Act regulations for air pollutant emission standards.

2. The Senate will vote to determine if it can move to actual debate on a bill to authorize funding for programs to combat prescription drug and heroin abuse. Senate Democrats have an amendment to add \$600 million in emergency anti-drug spending to the bill opposed by fiscal conservatives. The Senate may also return to consideration of the Energy Policy Modernization Act, which

has been stalled over the past month due to objections over an amendment that would authorize around \$280 million (down from \$600 million) for the water contamination crisis in Flint, Michigan.

3. On Tuesday, President Obama met at the White House with Senate Majority Leader Mitch McConnell (R-KY) and Senate Judiciary Committee Chairman Chuck Grassley (R-IA) to discuss whether the Senate will hold hearings on the President's upcoming nominee for the Supreme Court. The latest candidate to surface was U.S. District Judge Ketanji Brown Jackson, who is related to House Speaker Paul Ryan (R-WI) by marriage (his sister is married to Judge Jackson's brother-in-law). Also attending will be Senate Minority Leader Harry Reid (D-NV) and Judiciary Committee Ranking Democrat, Sen. Patrick Leahy (D-VT).

4. Last Friday, the U.S. Department of Transportation announced the first round of grants under its much-anticipated \$4.5 billion Highway/Freight grant program - christened as "FASTLANE" grants - with an application deadline of April 14, 2016. The December-enacted FAST Act authorized \$800 million in funding for the FAST-LANE program for FY 2016, with 25% reserved for rural projects, and 10% for smaller projects (under \$100 million).

5. Undersecretary of Education Ted Mitchell is leading a roundtable discussion on the role of Historically Black Colleges and Universities in helping to diversify the STEM pipeline and meet workforce needs. HBCUs produce 27 percent of African Americans with bachelor's degrees in STEM fields, according to the Education Department. The event was held at the National

Academies of Sciences, Engineering, and Medicine.

6. Vice President Biden introduced Lady Gaga at the Academy Awards Sunday night, but not before encouraging the audience to help change the culture of sexual abuse both on college campuses and off. "I'm asking you to join millions of other Americans, including me, President Obama, the thousands of students I've met on college campuses and artists here tonight to take the pledge, the pledge that says I will intervene in situations where consent has not or cannot be given," Biden said. "Let's change the culture." Lady Gaga's song "Til It Happens to You," was used in the documentary on sexual assault called, "The Hunting Ground." 7. 2016 Presidential Watch. Tuesday was Super Tuesday, with 11 mostly Southern states holding their primaries --the exceptions are MN, VT, MA, and AK (which is holding GOP-only caucuses). There are seven more caucuses and primaries coming up on March 5 and 6 (LA, ME-Dems and ME-GOP, KY-GOP, KS, NE, and Puerto Rico-GOP). A new CNN poll out has Donald Trump leading the pack nationally by more than 30 points and, over the weekend, Trump picked up his first Senate endorsement - Sen. Jeff Sessions (R-AL).
