Washington in a Minute



Here are the top issues in Washington, D.C., this week:

1. The House and Senate are in session this week. House and Senate appropriators are nearing a deal on the FY 2018 omnibus appropriations bill--reportedly only about \$3 billion in differences remain to be solved before they can close out the FY2018 appropriations cycle. The current deadline to pass the bill is March 23.

2. On Monday, President Trump hosted a meeting with Israeli Prime Minister Benjamin Netanyahu at the White House. On Saturday, he will travel to Pittsburgh to host a campaign rally 3 days before the special election for Pennsylvania's 18th Congressional District, said to be a dead heat between Democrat Conor Lamb and Republican Rick Saccone in this one-time safe GOP seat. Last week, First Lady Melania Trump opened a White House summit on opioids that brought together leaders from the Trump Administration and from around the country to discuss education and prevention, treatment and recovery, and law enforcement and interdiction relating to opioids.

3. Following a Senate hearing last week, Transportation Secretary Elaine Chao appeared Tuesday before the House Transportation and Infrastructure Committee at a hearing on the President's infrastructure proposal.

4. Last week, Senator Chuck Grassley (R-IA) announced that on March 14 the Senate Judiciary Committee will hold a hearing on the Feb. 14 high school shooting in Parkland, Fla., that killed 17 students and faculty members.

5. President Donald Trump is poised to impose tariffs on steel and aluminum imports and possibly European cars this week, despite threats of retaliation from around the world and opposition from within his own party. On Sunday, Commerce Secretary Wilbur Ross and White House trade officer Peter Navarro stated that there will be no exceptions. Some Republican lawmakers and strategists fear the president's proposed tariffs of 25 percent on steel and 10 percent on aluminum imports will undermine their effort to maintain their majorities in Congress.

6. Democratic and Re-

publican Senators have listed campus safety as a top priority in the rewrite of the federal law governing higher education that they're working on meaning that, for the first time, the Higher Education Act could include rules for colleges dealing with allegations of sexual harassment and assault.

However, the Senators are divided on how schools should handle allegations, and leaders of the Senate education committee have repeatedly said they plan to produce a bipartisan Higher Education Act.

Still, there could be a way to find some common ground around a totally new model for handling assault

allegations: independent regional centers - in addition to colleges or police departments - that investigate complaints.

Champion Game Plan for Life

Matthew 18:21-22 says, Then Peter came to Jesus and asked, 'Lord, how many times shall I forgive my brother or sister who sins against me? Up to seven times?' Jesus answered, "I tell you, not seven times, but seventy seven times.'

Peter was probably not expecting this response from Jesus. And, many of us today are not prepared for this response, either. Because it's hard to forgive people who have hurt you even "one time," but Jesus is telling Peter that we need to forgive our brothers and sisters "seventy seven times". But let's face it, when someone hurts you or does you wrong, it's hard to forgive. Especially when the pain is so deep that it's hard to speak about the issue without getting upset. Whether it be in your distant past or immediate past, forgiveness is hard. So how can we forgive people ? I believe



that there are a few things we have to understand about forgiveness as it relates to this scripture. First, we have to understand that it's hard to forgive from an earthly perspective. Because the one who forgives is the innocent person who allows the guilty person that did wrong to go free. This is not normal and that's why it's hard. We see here in the text that this king showed his servant mercy and not the "justice" that the circumstance called for. So forgiveness starts with showing the same mercy that God shows us. Secondly, forgiveness is revealing, because it shows our weaknesses. Here again, we find in this text

that the King forgave a debt that his servant couldn't pay and yet this servant did not forgive a man that owed him a debt that was a "considerable" amount less. In this comparison, we see God's amazing grace is revealed. Because the King represents how God forgives us of our debt, no matter how much that we owe. That's why God demands that we look at others through the eyes of mercy, not justice. But the best thing we need to understand about forgiveness is the freeing power that it gives us. Because when we forgive, it sets us free from the pain of the past. But when we choose not to forgive people we release a negative spirit in our lives that robs us of our peace and our joy. That's why we need to get free from the hurt and the pain of the past that unforgiveness brings ... Stay encouraged, my brothers and sisters.

While serving as a member on many of the organizations' boards, she was the initiator of

was a lot like her home. That was fairly trendy then, but very commonplace now. Miss Davis was a trailblazer! We loved her.

Speaking of elders, we will be honoring a group of local elders on Saturday, March 10. These elders are at least 70 years old and are still living and giving in this community. The Rosetta James Foundation was has been sponsoring the "Honoring Our Elders" Celebration annually for 12 years now. The proceeds from this dinner celebration are used to award scholarships to students who give of their time and volunteer in the community.

This year, we are awarding \$25,000 in scholarships. Mrs. James is 92 years old and was honored by the 100 Black Men of America-Huntsville Chapter in December 2017, and by the Greater Huntsville Interdenominational Ministerial Alliance in January 2018 for her work in the local community. I was taught as a child to honor and respect the elders of our community. Teachers like Miss Davis and individuals like Mrs. James reinforced my love and respect for elders, thus explaining my passion and personal preferences regarding elders.

Last week, we attended the Legislative Update hosted by State Representatives Laura Hall and Anthony Daniels. Attendance was strong, and for two hours local citizens were able to engage and ask questions about issues ranging from education funding, to budget priorities, to health care to sentencing/prison reform. Citizen participation and engagement were robust.

March is Women's History Month. My earliest memories in life are related to wonderfully, strong women who motivated and encouraged me, including my own mother, women in our small-rural community, teachers throughout the life-cycle, traditional and contemporary leaders who continue to make and impact differences. 

Dismissing The Diabolical Ventriloquist

The Bible speaks of that disgusting and disguised ability of Satan to turn himself into "an angel of light." The Apostle Paul warned his Corinthian readers of this menacing method of the enemy. He spoke this warning in the context of his teaching about the fact and fate of false teachers.

There is however, an even more subtle sound that believers must be mindful of; the sound of the diabolical ventriloquist. Only Jesus can teach us how to dismiss, define and discern that voice. Those who are really good at ventriloquism are so because they can "throw their voices" into a character that they are manipulating and do so without moving their lips. Satan is always seeking to do just that.

Jesus confronted that cleverly concealed voice when Satan used the lips of Peter to rebuke Jesus when He told His disciples that His salvific purpose and purchase included suffering many things from the elders and chief priests and being killed. As soon as those words came from Peter's lip, Jesus immediately dismissed and discerned who it was; "Get behind Me, Satan!" He



then defined the voice so that all believers can discern it; "You are an offense to Me, for you are not mindful of the things of God, but the things of men." That's the choice that every believer has and must make. The only way to make the correct one is by doing what Jesus did; dismiss, discern, and define.
