

# Washington in One Minute



Here are the happenings in Washington, D.C., this week:

1. CONGRESS. The House and Senate are in session this week. The House, among other items, will take up a resolution to strike the Biden's Administration new "Waters of the United States" rule; a bill to recall the 900 U.S. troops stationed in Syria; and a bill to expand the Hatch Act to forbid federal employees from censoring content on social media platforms (the GOP contends that government officials improperly compelled Twitter and Facebook to take down COVID-19 misinformation during the pandemic). The Senate is expected to take up a House-passed resolution to reject D.C.'s newly enacted Revised Criminal Code Act, which among other things, reduces maximum penalties for crimes such as carjacking, robbery and burglary. With 2 Democratic Senators in the hospital (Sens. Feinstein, D-CA, and Fetterman, D-PA) and Sen. Manchin (D-WV) announcing that he will vote for the resolution (and President Biden announcing last Thursday that he would not veto the bill), the bill is expected to pass the Senate.

2. THE WHITE HOUSE. On Sunday, President Biden visited Selma, Alabama to mark the 58th anniversary

of Bloody Sunday commemorating when 600 civil rights marchers were attacked and beaten by state troopers and sheriff's deputies on the Edmund Pettus Bridge in 1965. On Thursday, the President sent his Fiscal Year 2024 Budget to Congress and, on Friday, he will host a meeting at the White House with European Commission President Ursula von der Leyen.

3. SUPREME COURT. Last Thursday, the Supreme Court released a brief, oneparagraph order pertaining to the potential blockbuster case of Moore v. Harper, in which North Carolina GOP lawmakers challenged a then-Democratic-con-

trolled state supreme court decision striking down gerrymandered congressional maps. On Feb. 3, 2023, the new GOP majority North Carolina Supreme Court announced it would rehear the case and, therefore, the U.S. Supreme Court is now unlikely to issue a decision in the case (for which it heard oral arguments on Dec. 7, 2022). The Moore case relies on the independent state legislature doctrine, which says that state courts do not have jurisdiction over how state legislatures decide the elections for Congress and the presidency will be conducted in their state.

4. COVID ORIGIN HEARING. On Wednesday at 9 a.m., the House Select Subcommittee on the Coronavirus Pandemic held a hearing on "investigating

the origins of COVID-19," featuring testimony from former CDC Director Robert Redfield.

5. RAILROAD DERAIL-MENT HEARING. On Thursday at 10 a.m., the Senate Environment and **Public Works Committee** held a hearing addressing the environmental and public health threats from the Norfolk Southern train derailment and chemical release in East Palestine, Ohio. Alan Shaw, the President and CEO of Norfolk Southern Corporation, testified.

6. DEPARTMENT OF LABOR SEEKING INPUT. The U.S. Department of Labor is seeking input on strategies and partnership models from stakeholders involved in economic and workforce development, particularly on partnerships that address the workforce needs of specific industry sectors within a local or regional labor market. More information is available. The deadline to submit input is March 24, 2023.

7. CHERRY BLOS-SOMS. Yes, it's that time of year again and last week the National Park Service announced that, due to a warmer-than-average February, D.C.'s cherry blossoms lining the Tidal Basin will reach peak bloom between March 22 and 25 (ahead of the usual peak around April 4).


For those who need a snack, food trucks will have items available for purchase.

#### The Originator of Basketball (James of Naismith) vs. The Originator of Christianity (Jesus of Nazareth)?

"Can two walk together, except they be agreed?" Amos 3:3.

In my last article, I shared how Synovus Bank relationship officer Robert Livingston's offhanded reminder inspired: basketball was invented at a gymnasium of the Young Men's Christian Association (YMCA), https://bit.ly/3ZAAN1b.

That reminder broke my writer's block and re-energized me in writing my Where Jump Shots Meet Jesus manuscript, intersecting basketball and the Bible.

As the Christian world celebrates the Lent season of February 22 to April 7, and college and professional basketball get ready for March Madness and the NBA playoffs, respectively, I ask: how does the originator of basketball (James Naismith) intersect the originator of Christianity (Jesus of Nazareth)?

Here are a few parallels:

#### James of Naismith

as a foreigner.

Came to the US from Canada,

Hired as both a YMCA chaplain (who provides spiritual care) and an instructor in physical education.

Ordered by the "Y" to calm its "rowdies," now restricted to indoor activities due to harsh New England winters; it was then and there that Naismith invented the game of basketball!

From that first basketball game in December 1891, Naismith's invention and releasing his disciples to has become one of the world's most popular sports

#### Jesus of Nazareth

Came to earth as a foreigner: the first and only fully divine and fully divine and fully human being.

Provided spiriual care (chaplaincy, and instructed his disciples as they traveled with him from town to town only by walking (physical + education)--can you imagine how many steps their "FitBits" logged in each day!?!

Prayed all night (Luke 6:12) for divine guidance in selecting his 12 disciples, which resulted in Christ choosing 12 rowdies such as impetuous hothead Simon Peters, tax gouging Levi Matthew, doubting Thomas, betrayer Judas Iscariot...

From his appointing, training, spread his Gospel called Christianity, it is now the the world's largest religion with 2.56 billion followwers

Perhaps you will now see how there's a greater parallel between sports and spirituality and more specifically, between basketball and the Bible

Sophia Davis was born in Athens, Alabama, circa
1859. She graduated from Fisk University in Nashville, Tennessee. She was a teacher and pianist.
On October 20, 1881,
Scruggs owned land on Pelham Street in 1883;
Lowe Avenue in 1899; a large farm in 1900; and city property on Barnett and Pump Streets.
The following article was

The following article was published in The Journal newspaper on April 19, 1901:

A new and novel enterprise recently opened up on the corner of Holmes and Clinton Streets, by Mesdames B. E. Scruggs, A.E. Douglass and T. S. Donegan and Miss Lula Tivis.

It is the grandest colored enterprise in the city. They serve cream, soda water, candles and cakes, as well as groceries. In connection with this department they have a sewing department under the direction of Miss C. R. Jones.

This department is now

ready to make gents' shirts, overalls, etc., as well as ladies' dresses.

Give them a call and you will come away well satisfied. On the second floor you will find the offices of Mrs. Dr. Ford, Dr. B. E. Scruggs and contractor, D S Brandon.

In 1882, Sophia was an instructor at the State Normal School. Her monthly salary was \$30.00. She also taught at the city colored school.

Sophia died on January 10, 1923. She is buried in historic Glenwood Cemetery.

#### Bulldogs Finish Regular Season with Win Over Southern

For the first time since the 2010-11 season, Alabama A&M men's basketball secured a series sweep over Southern, with a 68-65 win on March 4 inside of the F.G. Clark Activity Center in the regular season finale.

Xavier Brewer and Lorenzo Downey led A&M offensively on the day with 16 points each, while Messiah Thompson also finished in double-digits with 11 points and four assists. Meanwhile, the Bulldogs finished the game with shooting splits of 56.5 (26-for-46) percent from the floor and 52.4 (11-for-21) percent from deep in the win.



# Finding the Right Therapist

(BPT) - According to a recent Forbes Health poll, improving mental health was cited as one of the top New Year's resolutions for 2023. For those seeking a mental healthcare provider, finding the right one can feel much like dating - overwhelming to find someone who shares the same values, meets your needs, and

with whom you feel a connection. However, finding an attentive, caring and knowledgeable therapist can pay dividends on your mental well-being.

"Working with a provider with whom you have a strong and trusting relationship can have a signifi-
