



Lions, AKAs Partner on Vision Initiative

The Von Braun Lions Club chapter of Lions Clubs International and Alpha Kappa Alpha Sorority Incorporated, Epsilon Gamma Omega Chapter, have partnered to participate in an eyeglass initiative designed to prevent blindness, help restore eyesight, and improve eye health and eye care for millions of people around the world by donating new and used eyeglasses.

Both organizations have developed programs of service that will allow everyone to see a better tomorrow.

The chapters of each organizations will work together to plan and create community service projects that will focus on sight programs to include vision screening, eye banks and eyeglass recycling and providing eye care services to those at risk of losing their

To date, Epsilon Gamma Omega Chapter has donated over 500 pairs of new and used eyeglasses to the Von Braun Lions Club since the

partnership was formed. These glasses will be delivered to the Eye Center in Birmingham, retrofitted and shipped or delivered to the underprivileged in undeveloped countries.

Lions Clubs International was founded in 1917 by Chicago businessman Melvin Jones. In his opinion, a club should do more than promote the business of its members; it should service the community. Lions Clubs International has grown to be the largest service club in the world with nearly 1.35 million members in almost 46,000 clubs in 197 countries and geographic

At the 1925 International Convention, Helen Keller challenged the Lions to be "knights for the blind." The Lions took on sight conservation as their major project but are recognized the world over for outstanding service to their communities and the world as a whole.

Alpha Kappa Alpha Sorority, Inc. (AKA), the oldest Greekletter organization established for African American women, was founded on January 15, 1908, on the campus of Howard University in Washington, D.C.

The principles are Sisterhood, Scholarship, and Service to All Humankind. AKA is dedicated to implementing programs of service that enhance the social, economic, and educational well-being of the local, national and international communities.

The current International Program Targets are designed to advance the mission of the sorority with excellence and underscore our commitment to sustainable service. The five program targets are HBUC for Life: A Call to Action, Women's Health and Wellness, Building Your Economic Legacy, The Arts and Global Impact. This partnership will focus on AKA's Target 5: Global Impact.






