Following an almost two-hour hearing before a judge on Friday, March 29, Huntsville City School Board Member Michelle Watkins was acquitted on a December harassment charge.

Watkins has called her heated exchange a few months ago with Dr. Linda D. Burruss, principal of Rolling Hills Elementary School in northwest Huntsville, "a disagreement between two adults" that would in no way impact her support for the school and its principal.

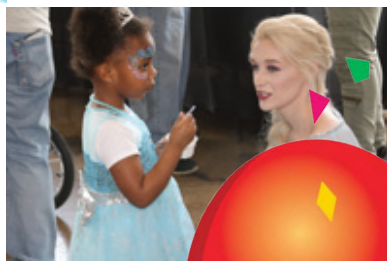
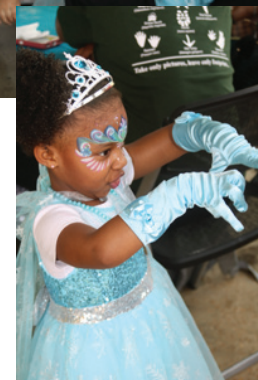

Washington in One Minute



Here are the top issues in Washington, D.C., for this week's edition.

1. The House and Senate are in session this week. The Senate will continue work on the \$13.4 billion FY2019 emergency supplemental appropriations bill, which was passed by the House in January to provide aid to Gulf Coast states hit last year by hurricanes as well as Midwest states that suffered more recent flooding and additional funding for Puerto Rico to recover from the 2017 hurricanes ... The House will vote on a resolution condemning the Trump Administration's March 25 decision to oppose all provisions of Obamacare, including the protections for pre-existing conditions; a resolution to pull U.S. troops out of Yemen, and a bill to reauthorize the Violence Against Women Act.

2. President Trump spoke at the White House Prison Reform Summit, trumpeting the enactment of the First Step Act in December 2018, which reformed sentencing guidelines ... On Wednesday, the President had dinner with senior Pentagon officials, and, on Thursday, he had an event with the White House Opportunity and Revitalization Council, which was created in December 2018 to direct federal resources to the Opportunity Zone Program and is chaired by HUD Secretary Ben Carson. On Friday, the President heads to Calexico, CA for an event at the border, followed by a fundraising event in Los Angeles. On Saturday, the President will address the Republican Jew-

ish Coalition at the Venetian Hotel in Las Vegas.

3. On Thursday, the Senate Homeland Security/Government Affairs Committee held a hearing on the "Unprecedented Migration at the U.S. Southern Border." According to Axios, Homeland Security Secretary Kirstjen Nielsen this week will seek permission from Congress to deport unaccompanied migrant children and hold families seeking asylum in detention longer than currently permitted, citing a system-wide breakdown at the U.S./Mexico border.

4. The Senate HELP Committee is continuing work on legislation to reauthorize the Higher Education Act. Chairman Lamar Alexander (R-TN) has said his goal is to report legislation out of committee by spring so the Senate can consider it this summer. The full committee will hold a hearing April 2 on campus sexual assault, which coincides with the Education Department's effort to write new rules for how schools handle sexual assault allegations under Title IX, the law that bans discrimination on the basis of sex for education programs receiving federal assistance. The department is reviewing more than 100,000 public comments.

5. Last Thursday, the Senate Budget Committee approved its budget for Fiscal Year 2020 without breaking the FY2020 budget cap (set by the Budget Control Act of 2011), which would cut \$126 billion in federal discretionary spending, including a \$73 billion cut at the Pentagon and a \$98 billion cut for domestic spending. On the mandatory spend-

ing side, the Senate would cut spending on Medicaid, children's health insurance and Obamacare subsidies by \$281 billion and cut Medicare by \$77 billion. House Budget Committee Chairman John Yarmuth (D-KY) reportedly will make a decision today on whether to move forward with a FY 2020 budget resolution or just move legislation that will allow appropriators to mark up to higher budget caps ...

6. Last Friday, Attorney General William Barr wrote to Congress saying that his ongoing redactions of Special Counsel Robert Mueller's Report will take until mid-April. House Judiciary Committee Chair Jerrold Nadler (D-NY) has demanded that Barr release the full report plus the underlying evidentiary documents to Congress by April 2. According to NBC News, House Judiciary Committee staffers are working on a subpoena if Barr fails to meet the April 2 deadline.

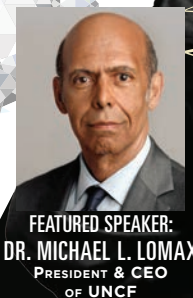
7. A new poll conducted of 640 adults The Washington Post and George Mason University on March 26-29 found that 83% of Americans believe that Special Counsel Robert Mueller's Report should be made public in its entirety and 53% say that Attorney General Barr has not released enough details about the report. When asked whether President Trump committed "serious wrongdoing" during the course of the 2016 election or in the federal investigation that followed, 46% said no, 37% said yes and in their view, it rose to the level of criminal activity, and 6% said that while he may have committed serious wrongdoing, he did not commit a crime.

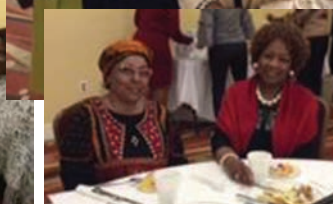

CROWDS

Luke 5:17-19; Mark 5:25-29; Matthew 5:1-2a

Crowds are not an unusual sight in our society. We see them at sports events, church, banquets, concerts and the like. Each of these events can be and usually are for those in attendance, an enjoyable experience. However, crowds can also be a hindrance; they can harm; and they can handicap. So how does one handle being hindered, harmed, or handicapped, especially when the crowd has the potential of keeping them from Jesus?

There are two examples in the above scriptures that help answer that question. In the Luke passage we see four friends working compas-

sionately and cooperatively to get their friend to Jesus, but they were hampered by a crowd. Their solution was to go ABOVE them by going on the roof top and with some creative genius, resulted in the healing and

salvation of their friend. In Mark there was the infamous story of the woman with an issue of blood. She too was confronted with a crowd. How did she handle it? She couldn't go ABOVE them as the four had, but she didn't worry ABOUT them; allowing them to cause her to miss touching Jesus' garment, and because of that



mindset, she was able to extract that self-prescribed power from His Person and also was healed.

How did Jesus handle crowds?

It was not by going ABOVE them; although He could

have. But because He cared ABOUT them, we are told that He ABODE with them and taught them.

Springtime ... managing lawns, weeds - egos?

"Can a leopard change its spots, or an Ethiopian his skin?" - Jeremiah 13:23

On Our Lawns . . .

Outside our home's kitchen windows were two "Hi, We're Back!" signs: green and white budding tree branch tips and purple flower-like weeds.

Spring has sprung - and with it, my constant reminder of needing God's management of things that grow naturally - like egos.

Lawn upkeep is not simply an early March one-and-done activity; instead, the best lawncare management requires constant (often weekly) mowing, pruning, trimming, edging and disposing of excesses deemed unnecessary. The lawn will not manage itself.

In February, I even applied weed-killing spray to stop that purple surge. While it's working currently, months from now, however, those purple wanna-be flowers will re-surface and therefore need re-management. They, too, will not manage themselves.

My grass and hedges will neither cut or trim themselves nor will my weeds cure, solve and eliminate themselves. As our lawn's steward, I can and must only manage these natu-

ral growths with consistent watch care . . .

. . . Just like God helps us manage our ego-holism - our addiction to self. States Ryan Holiday, author of *Ego Is The Enemy*: "Your ego is not some power you're forced to satiate at every turn. It can be managed. It can be directed."

. . . *And In Our Lives*

Q: Are you like me struggling unsuccessfully with such ego-holisms as procrastination, selfishness, arrogance, poor eye contact, blame-gaming (excuse making), dis-organization and even more selfishness?

The Bad News? You and I are stuck forever with those "character potholes." They are embedded in our lives' hard-drives. And try though you and I might, those and other ego problems cannot be cured, solved or eliminated, but . . .

The Good News? Just like the even lengths of your lawn grass; the sculpted shape of your hedges; and the presence of those weeds, our lives' "character weeds" (e.g., lust, pornography, conceit, low-/no esteem, etc.) can only be managed through an ongoing management partnership with God.

Just like your and my lawns

and weeds cannot cut, trim or eliminate themselves but need our regular

management maintenance, our character weeds cannot solve, cure and eliminate themselves, but also need our God-us management.

Ego-holism is "the addiction to self" - displayed either as arrogance, boastfulness or pride (big egos), and/or low-/no esteem, insecurity or feelings of inadequacies (little egos); ego-holisms (both big and little egos) equally affect and drain every person, organization, event or activity. God is gifting me to expose my own ego-holism(s) and to share my ongoing recovering journey, by overlapping Biblical best-practices with current events/newsmakers that illustrate characteristics of this addiction.
