Former Commissioner Preyer Honored at Luncheon

A former Madison County Commissioner was honored by friends and family during a recent luncheon held April 27 on the campus of Alabama A&M University (AAMU). Dr. Prince Preyer, Jr., served 46 years in the field of education and public service. He received his B.S. degree in agriculture in 1958 from AAMU, his M.S. degree in agriculture from Tuskegee Institute (University) in 1971 and his Ph.D. from Iowa State University, in 1976.

He began his college teaching at AAMU and

completed 30 years in the field of education before retiring.

After retiring from AAMU in 1988, he was elected to the Madison Commission and served as a Commissioner for District 6 for 16 years. He was the first African American to be elected to the Madison County Commission since re-construction.

As Commissioner, Dr. Preyer was instrumental in starting several social programs which addressed the needs of youth minorities at risk (COARM); and the Phoenix Program, which



focused on working with youth and their parents. The annual Job-a-Ton was a successful program that assisted over 5,000 youth in Madison County to find Summer jobs over several years.

During Dr. Preyer's tenure in office, he was successful in obtaining funding for District 6 through Federal Grants totaling over \$13 million. These programs helped to enhance and strengthen the various social programs.

Through the Commission, under Dr. Preyer's leadership, District 6 contributed \$5 million to site work done at AAMU's Louis Crews Stadium and the Ernest L. Knight Center.





Matthew 26:6-8





Spotlight on Our Elders ... Featuring

Mrs. Gladys L. Branch

When Gladys L. Branch received her diploma as a Top 20 student at Birmingham's Hooper City High School in 1964, she knew that there were still plenty of opportunities during a turbulent time in America during the 1960s. She entered historic Alabama A&M University, where she received the Bachelor of Science degree in mathematics and general science in 1968. She returned to obtain her Master of Science degree in guidance and counseling.

Over the years, Mrs.
Branch has developed an impressive career that has spanned more than 40 years. For some five years, beginning in 1969, Branch was an elementary and middle school teacher for the Athens (Ala.)

City School System, where she prepared and carried out lesson plans for second graders and later for math and science students at the middle school level.

In 1974, she served one year as a counselor for the Huntsville Sickle Cell Center before returning for a final year of mathematics, teaching at Westlawn Middle School. She remained at Westlawn for an additional 20 years as a general counselor and then as a vocational counselor until 1996.

In August 1996, Branch decided to use Westlawn as a base for a position in administration and served as Westlawn's assistant principal for four years. She was acting principal for a year



at McDonnell Elementary School before culminating her career as principal of Rolling Hills Elementary School.
