Here are the happenings in Washington, D.C., this week:

1. ON THE FLOOR. The House and Senate are in session this week. On Sunday, Senators Murphy (D-CT) and Cornyn (R-TX) announced that a bipartisan group of senators had reached a deal on gun control legislation. The bill (which has not yet been written) will include: (1) resources for states to implement red flag laws to keep firearms away from people deemed a risk to themselves or others; (2) a more rigorous background check process for people aged 18 to 21, with enhanced review that includes contacting state and local law enforcement for criminal records that could be disqualifying, and to appropriate state organizations for mental health information that could impact the decision; (3) increased requirements for who must register as a federally licensed firearm dealer for the purposes of conducting background checks; (4) new penalties on straw purchasing of firearms to improve prosecution of traffickers; and (5) a provision to address the so-called "boyfriend loophole" on domestic violence, meant to cover stalkers and current or former dating partners. The House, among other items this week, will take up the Ocean Shipping Reform Act and the Lower Food and Fuel Costs Act, which would create a permanent waiver for the sale of E15 gasoline (15% ethanol) during the summer and establish a USDA loan program to encourage new meat processors and expand slaughter capacity. The House will also

debate the Financial Services Racial Equity, Inclusion, and Economic Justice Act, which would require the Federal Reserve to carry out its duties in a manner that supports the elimination of racial and ethnic disparities in employment, income, wealth, and access to affordable credit.

2. THE WHITE HOUSE. The White House was expected to announce Monday President Biden's travel in July to Israel and Saudi Arabia, to include a meeting with Saudi Crown Prince Mohammed bin Salman. On Tuesday, the President traveled to Philadelphia to speak at the AFL-CIO Convention ... Last week, Politico reported that the Biden Administration had scrapped President Trump's plan to change the paint design of the next generation of Air Force One-designated Boeing 747-800s ...

3. FED MEETING. This Tuesday and Wednesday, the Federal Reserve's Federal Open Market Committee met and was expected to raise the federal funds target rate range by a half percentage point, but there was some speculation that Federal Reserve Chair Jerome Powell could announce a more aggressive pace of future rate hikes at a press conference on Wednesday in view of Friday's report that the May consumer price index rose 8.6% year-over-year, its highest level since 1981, causing a steep drop in financial markets with the Dow down 880 points last Friday. 4. FY2023 APPROPRIA-

4. FY2023 APPROPRIA-TIONS. On Wednesday, the House Appropriations Committee began its subcommittee (and full committee) markups

for the 12 Fiscal Year 2023 appropriations bills, starting with the Defense, Legislative Branch, Military Construction, and Agriculture appropriations bills. The markups will conclude on Thursday, June 30. **5. JANUARY 6 COMMITTEE** HEARINGS. On Monday, the House January 6 Select Committee held its 2nd hearing, focusing on the effort by the Trump Administration to spread false information about the 2020 presidential election with former Trump campaign manager Bill Stepien and former Fox News staffer Chris Stirewalt as witnesses. Hearing #3 on Wednesday (June 15) discussed the alleged plot to influence and possibly replace the U.S. Attorney General to further false election claims with witnesses former Acting Attorney General Jeffrey Rosen and other former Justice Department officials. It has been reported that the committee may hold a 4th hearing with former chief counsel to Vice President Pence, Greg Jacob, as a witness.

6. SUPREME COURT. On Monday and Wednesday, the Supreme Court was scheduled to issue opinions from its current docket, with many big decisions – such as the Mississippi abortion case - still to be announced. In related news, The Washington Post reported that a 26-year-old Simi Valley, California, man, who arrived outside Justice Kavanaugh's home in Maryland last Wednesday morning with a gun in his luggage, was charged by federal law enforcement officials with attempted murder and remains detained pending further court proceedings. The man, Nicholas Roske, called 911 to turn himself in after seeing 2 deputy U.S. marshals outside the justice's home and reportedly was upset by the leaked draft of an opinion to overturn Roe v. Wade and a belief that Justice Kavanaugh would side with 2nd Amendment decisions that would loosen gun control laws.

7. HIGHER EDUCATION. More than a dozen tech, com-

munity college and online university leaders are urging lawmakers to remove a proposal in the final Bipartisan Innovation Act that would exclude students enrolled in online education programs from accessing short-term Pell grants. In a June 13th letter to congressional leadership, college leaders and the Skills First Coalition, led by IBM, argued the exclusion would largely block adult students from accessing the financial aid for programs as short as eight weeks. They cited barriers to education for working adult students, including inadequate child care and time constraints. Under the House-

passed America COMPETES Act, online-only programs and for-profit institutions are ineligible for short-term Pell grants. The group wrote they were in agreement with protections to support quality programs but said leaving online programs out denies access to a significant population of students who must receive the skills needed to be able to contribute to the workforce and improve their lives.





## The "Return" of Coco Gauff

*"We are cracked and chipped from our afflictions on all"* sides, but we are not crushed by them. We are bewildered at times, but we do not give in to despair." - 2 Corinthians 4:8

We have often observed that some of our biggest defeats happen typically after our biggest victories. But can it also be true that our biggest victories will

come as a result of learning from our biggest defeats?

That's the plan according to rising tennis star Coco Gauff. the most recent French Open semi-finalist. While Gauff

Open winner Iga Swiatek, the 18-year-old then pivoted to planning for her next encounter against this topranked woman.

As she intimated in her interview, Coco Gauff looks forward to next time after French Open loss - KSTP.com Eyewitness News, Gauff's earlier successes came from focussing on an upper level, then practicing to reach it.

Now having seen Swiatek's level of No. 1 world ranking and 35 straight match victories, "I know what I have to do, . . . I'm sure I'm going to play her in another final and, hopefully, it's a different result."

"A different result" is what the Apostle Paul was preparing the new Corinthian Christians for in the above Bible text. They had been in heated verbal and sometimes physical conflicts with their countrymen who refused to accept this newfound Christianity.

Paul encouraged them not to despair or to give in. Instead, he exhorted them to look up, see, and try to reach that next level of their faith: become more like Jesus Christ. Pursuing Christlikeness would become their pathway to the top.

Likewise, Gauff said she would now view her loss to Swiatek less as a defeat, but now more as a sneak preview into how to prepare for and succeed at that next level.

We should all be so aware of how to view our setbacks - not as stumbling blocks, but as stepping stones to our next levels of success.

# Dr. Razi Hassan

Dr. Razi (Bobby Blockum) Hassan is a native of Birmingham, Ala., where he was educated in the public school system before pursuing his postsecondary education in chemistry and mathematics at Knoxville College (Tenn.). He studied physical chemistry at Princeton University before eventually settling at New York University, where he earned the Ph.D. degree in theoretical chemistry.

Hassan devoted some 25 years as community organizer with the Student NonViolent Coordinating Committee (SNCC), registering African-American voters in Arkansas and Mississippi in the mid-1960s. During those eventful years, he also helped to organize a credit union and school for dropouts in Trenton, N.I. At the onset of the 1970s, Hassan organized food coops, a community literacy program and another school for high school dropouts as part of this service at the Harlem Mosque in New York. Moreover, from 1990-97, he was counselor, GED instructor and Imam (minister) at Limestone **Correctional Facility** 



in Alabama. Hassan concurrently directed a tutorial center for mathematics and chemistry in Huntsville, Ala., from 1993-98. The educator has been affiliated with Alabama A&M University for nearly 25 years, primarily as an associate professor of chemistry at Alabama A&M University and director of the chemistry and mathematics tutorial center.

In 2004, Hassan led a team of AAMU students on a NASA-sponsored rocket launch competition in Manchester, Tenn. However, the goal at that time was two miles (more than 10,000 feet). A Proteus rocket, fondly named "Butch" after the school mascot, reached 1.8 miles, falling short of rival

UAH, which achieved 1.9 miles. However, the UAH rocket was not successfully retrieved. This led toward an overall win by the AAMU team.

Additionally, Hassan

has managed numerous government programs with aggregate budgets exceeding \$12 million in his capacity as a project director or codirector, coordinator, budget manager or principal investigator.

His numerous affiliations include American Chemical Society: an advocate for the homeless through the First Stop organization; National Conference For Community Justice (NCCJ), Board Member; Interfaith Mission Service (IMS); leader of a local mosque; Assistant Iman, W.D. Muhammad Muslim Center; advisor, Muslim Students Association of Alabama A&M University; and advisor, Future Physicians Society.
