Local Educator Named Einstein Fellow

Candyce A. Curry has been selected to serve as a 2022-2023 Albert Einstein Distinguished Educator Fellow. The program provides an opportunity for accomplished K-12 Science, Technology, Engineering and Mathematics (STEM) Educators to apply their extensive classroom knowledge and experiences to their host offices to enhance federal STEM education efforts.

As one of only 15 K-12 STEM teachers selected from across the U.S., Candyce will spend 11 months engaged in the national STEM education arena, while serving in the U.S. Geological Survey of the

U.S. Department of the Interior.

Curry is currently employed by the Birmingham City Schools system at Putnam Middle School as a curriculum specialist.

She holds the distinct honor of being selected as “Teacher of the Year” for two consecutive years at Huffman High School, where she formerly served as a Life Sciences Educator. She is the daughter of the late Charles



Curry and Pamela Curry, and she is the sister of Kelli Curry.

Educated in the Huntsville City Schools system, Curry is an alumna of Lee High School, Stillman College and Alabama A&M University.

Tennessee Valley Remembers Local Activist, RJF Elder

Huntsville and its surrounding areas are mourning the recent death of local activist Jacqueline Reed. Reed was also a Rosetta James Foundation Elder.

“Jackie” Reed devoted considerable time to ensuring that the political atmosphere of Huntsville

remained fair, balanced and void of “the good old boy club.”

For years, she was a consistent contributor to “One Woman’s Opinion,” a regular column in Speakin’ Out News, a popular African-American weekly.

For over 30 years, she dedicated time to attending

City Council and governmental meetings, monitoring budgets affecting all citizens. Since 1988, she ran for Mayor seven times. She ran City Council six times, and one legislative position. She felt pride from choosing others’ needs over her own, and she earned utmost respect.

Washington in One Minute



Here are the happenings in Washington, D.C., this week:

1. **ON THE FLOOR.** The House and Senate are in session this week. The House will take up the 1st package of 6 FY2023 appropriations bills (T/HUD, Ag, E&W, MilCon/VA, FinServ, and Interior) and will also vote on the 3rd of a trio of abortion-related bills, which would codify the right of people to obtain and use contraceptives, including all contraceptives approved by the Food and Drug Administration, including oral and emergency contraceptives, intrauterine devices and condoms (last week, the House passed 2 bills to legalize abortion services nationwide and to protect the rights of women to cross state lines to seek abortion services). The House may also take up a bill to provide \$52 billion to the semiconductor industry, although it has also been reported that the semiconductor funds may be added to a filibuster-proof Budget Reconciliation bill (see item #3 below), which the Senate and House leadership is trying to revive. The Senate starts off its week with debate on 2 federal judge nominees. According to Reuters, the Senate has confirmed 69 federal judges of the 123 nominated by President Biden since January 2021.

2. **THE WHITE HOUSE.** President Biden returned to the White House on Sunday morning from his trip to Israel, the West Bank and Saudi Arabia. Last Friday, the President issued an executive order creating a Presidential Emergency Board to avert a strike by 115,000 rail workers

for the next 60 days and to help negotiate new contracts between the 12 unions and the railroads. Also last week, the White House announced that public tours will resume a full schedule starting on Tuesday with tours Tuesday-Saturday from 8 a.m.-12:30 p.m.

3. **RECONCILIATION BILL.** The Senate leadership will begin vetting a slimmed-down version of the filibuster-proof Budget Reconciliation bill with the Senate Parliamentarian this week as a prelude to possible Senate floor action. After having the climate provisions and new taxes on wealthy individuals and corporations in the bill vetoed by Sen. Joe Manchin (D-WV) last week, the Senate, reportedly, will move forward on a bill focused on lowering prescription drug prices and extending Affordable Care Act subsidies.

4. **ASSAULT WEAPONS BAN.** On Wednesday, the House Judiciary Committee will markup a bill to ban assault weapons, which the House leadership intends to bring to the floor before the August recess. The previous assault weapons ban expired

in 2004, ten years after being signed into law by President Bill Clinton as part of 1994's Violent Crime Control and Law Enforcement Act.

5. **JANUARY 6 COMMITTEE.** The House January 6 Committee held a primetime hearing Thursday (July 21) at 8:30 p.m., which focused on President Trump's actions as rioters breached the Capitol and forced lawmakers to flee their chambers. Last Friday, in its first such action to an Executive Branch agency (after learning that some records were deleted), the committee issued a subpoena to the U.S. Secret Service requesting text messages and any "after action" reports pertaining to the events of January 6, 2021.

6. **MILWAUKEE 2024.** Last Friday, the GOP's site selection committee picked Milwaukee as the host city for the 2024 Republican Convention. The full Republican National Committee will vote to seal the deal during its summer meeting in Chicago on August 2-5. The 2020 GOP convention was held in a scaled-down version due to Covid in Charlotte, NC.

7. **EDUCATION - TITLE IX.** On last Friday, A federal judge temporarily blocked the Education Department's Title IX guidance, which prohibits discrimination based on gender identity and sexual orientation. Eastern District of Tennessee Judge Charles Atchley stated in an order that the agency's guidance "directly interferes with and threatens Plaintiff States' ability to continue enforcing their state

laws" that restrict transgender people from playing on sports teams and using bathrooms that match their gender identity. The plaintiff is a coalition of 20 Republican attorneys general led by Tennessee Attorney General Herbert Slatery that have argued their states face a "credible threat" of losing significant federal funding due to their policies and laws. The defendants, which include the Education Department, Equal Employment Opportunity Commission and Justice Department, urged the court to dismiss the lawsuit, which Atchley denied. The preliminary injunction essentially ties the department's hands when it comes to protecting transgen-

der students from discrimination in 20 states that have laws or are attempting to pass laws that restrict their access to facilities and sports. The department will have to finalize its Title IX rule to enforce its guidance.

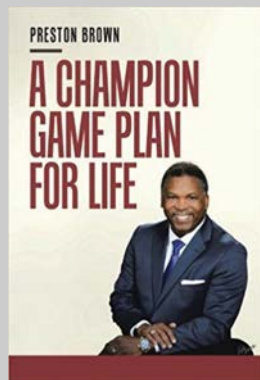
You know, sometimes it's easy to have good intentions but bad motivation for doing something.

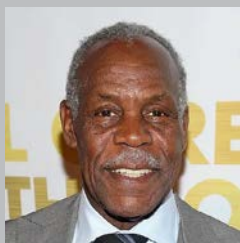

June 30 - July 7: Early Signs of “#BlackGirlMagic 2.0”?

“Fear not, for I am with you; Be not dismayed, for I am your God. I will strengthen you, Yes, I will help you, I will uphold you with My righteous right hand” - Isaiah 41:10

With these words, Isaiah assured Israel that God destined them to be victorious; therefore, He would protect and strengthen that nation through setbacks and trials that seemed unending.

The current epidemic of mass shootings, character and political assassinations, and Supreme Court reversals of longstanding human and environmental protections makes it seem as though life overall is spiraling downward nationally. - June 30, with Ketanji Brown Jackson's Supreme Court swearing-in; then on
- July 6, Fulton County District Attorney Fani Willis not only subpoenaed top Trump officials but did not rule out subpoenaing Trump himself; also on
- On July 6, NY Attorney General Letitia James won a court victory in a civil investigation against Trump and his organization; and
- On July 7, President Biden awarded the Presidential Medal of Honor to gymnast GOAT Simone Biles and Sandra Lindsay, the first U.S. Covid-19 vaccinee,

CAUTION: however celebratory these milestones, each by their very reporting a past accomplishment. Now a part of immutable history. Therefore, are you or your own Black girls preparing now for an upcoming “#BlackGirlMagic 2.0”?

- No? Then follow the example of these five celebrated Black female trailblazers:
- Swear to uphold all that's true (Justice Jackson);
- Be unflappable in the face of political pressures (Attorneys Willis and James);
- “Take (the first) one for the team, the United States” (Nurse Lindsay); and
- Be ready to mount the unparallel bars of racial and sexual discrimination, yet dismount from them successfully like Simone Biles, . . .

Mrs. Rosa Rice Walker is a retired classroom instructor from the Huntsville City Schools System with more than 35 years of teaching experience in a variety of systems and settings.

Mrs. Walker's education career is broad and diverse, encompassing kindergarten through high school levels. Moreover, at the postsecondary level, she served as assistant director of the Career Testing and Education Development Center at Alabama A&M University; developed and administered summer learning camps at Alabama State University; and worked in admissions at Troy University (Ft. Walton Beach, Fla., campus). She has taught in public school systems in Alabama, Florida, South Carolina, Tennessee and Virginia. Beyond her public school experience, she also taught at a private Christian academy and served as a teaching effectiveness consultant at another. Additionally, she was a consultant and presenter with Empowerment Concepts, Inc., a business she co-founded with her husband.

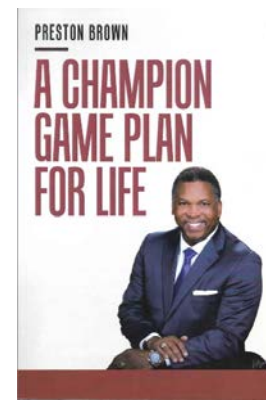
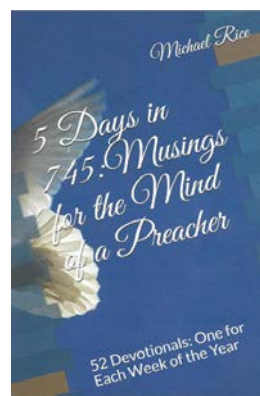

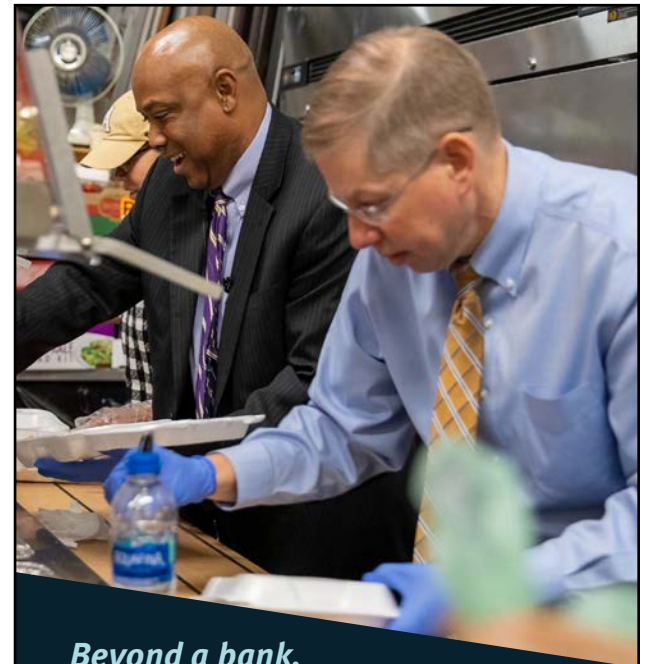
