HBO Orders Controversial Series, Hall of Famer Visits B&GC

Game of Thrones fans may have rejoiced when the critically acclaimed fantasy series returned for its final season on July 16, but the biggest twist didn't come from Westeros. The following week, HBO announced that it had ordered a full series for Confederate.

Helmed by GoT showrunners David Beinoff and D.B. Weiss, Confederate “takes place in an alternative timeline, where the southern states have successfully seceded from the Union, giving rise to a nation in which slavery remains legal and has evolved into a modern institution.” The show is set to feature characters from both sides of the spectrum, including “freedom fighters, slave hunt-

ers, politicians, abolitionists, journalists, the executive of a slave-holding conglomerate and the people in their thrall.” The controversial series is slated to premiere sometime in the fall after GoT concludes in August. Since the announcement, many have voiced their disapproval in the subject matter, calling it inappropriate and untimely. However, controversy is no stranger to Beinoff and Weiss. Game of Thrones, which is based on George R.R. Martin's best-selling novels, is known for its constant use of incest, murder and rape. Additionally, the provocative series has been scorned for its use of people of color, having them mostly portray slaves.

Seasoned African-American writers Nichelle Tramble Spellman and Malcolm Spellman, who have lent their talents to Empire, Justified and the Good Wife, are slated to join the series as executive producers and writers. In an interview with Vulture, Malcolm said the showrunners asked him and his partner to lunch, where they pitched the concept, which was originally a film. The project needed “black voices” and the writing duo, who will be tackling the Taraji P. Henson-led Proud Mary, were just the right fit. After hearing them out, the Spellmans were immediately on board.

“We deal with it directly and have for our entire lives.

We deal with it in Hollywood, we deal with it in the real world when we're dealing with friends and family members,” Malcolm said. “And I think Nichelle and I both felt a sense of urgency in trying to find a way to support a discussion that is percolating but isn't happening enough. As people of color and minorities in general are starting to get a voice, I think there's a duty to force this discussion.”

Despite the backlash, there is no official script or a cast. It appears that the series will be put on the back burner until GoT wraps in mid August.

Washington in a Minute



Here are the top issues in Washington, D.C., this week:

1. The House and Senate are in session this week. The House will adjourn at the end of the week for the five-week August recess, but the Senate, per Senate Majority Leader Mitch McConnell (R-KY), may stay in session for an additional two weeks if there is not significant action this week on its major agenda items ... Over the past week, there was a rollercoaster of voting scenarios touted, including voting on the revised Senate healthcare bill or a simple repeal of Obamacare with no replacement plan. Last Friday, the Senate Parliamentarian ruled that some provisions in the GOP healthcare bill, including defunding Planned Parenthood for one year and banning abortion coverage in Obamacare insurance plans, would require 60 votes to pass. Here are the key details to know:

- Coverage: Per the CBO, voting on a straight Obamacare repeal would result in 32 million more uninsured Americans by 2026 than under the current system. The revised Senate GOP healthcare bill would kick 22 million off healthcare.

- Premiums: With no replacement, average premiums in the individual market would double by 2026 under a repeal. Under the Senate GOP bill, premiums would decrease by 30%, but out-of-pocket

costs would soar for older and sicker people.

- Deficit reduction: an Obamacare repeal would lead to \$473 billion in deficit savings for the federal government through 2026. The Senate GOP bill would result in \$442 billion in savings over the same timeframe. Most of the savings would come from cuts to the federal Medicaid program.

The House will vote this week on a "minibus" appropriations bill combining the FY2018 Defense, Military Construction & Veterans Affairs, Legislative Branch, and Energy & Water Appropriations bills, which will include \$1.6 billion to start construction of the Mexican border wall. The House will also vote on a bill to impose new sanctions on Russia and to give Congress the authority to block the Trump administration from making changes to sanctions policy.

2. President Trump will participate in events for "American Heroes" week. On Monday, travelled to Glen Jean, W. Va., to visit the 2017 National Boy Scout Jamboree. On Tuesday, he hosted a campaign rally in Youngstown, Ohio, and he met with Lebanese Prime Minister Saad Hariri at the White House. On Wednesday, he spoke at the American Legion Boys Nation and American Legion Auxiliary Girls Nation events in DC. On Thursday, he par-

ticipated in an event honoring first responders.

3. On Monday, the President's son-in-law, White House staffer Jared Kushner, testified before the Senate Intelligence

Committee in a closed session. Last week, the Senate Judiciary Committee called

Donald Trump Jr., and former Trump campaign chairman Paul Manafort to testify this past Wednesday on their role in arranging a meeting at Trump Tower in June 2016 with officials connected to the Russian government.

4. Last week, the public comment period ended with more than 9 million comments received on a proposal by the Federal Communications Commission to consider overturning a 2015 rule that prohibited internet service providers from prioritizing or blocking internet content

- known as net neutrality. Additional rebuttal comments are due August 16.

5. Last week, the Federal Highway Administration released its latest National Highway Construction Cost Index, a quarterly estimate of the rising cost of domestic highway construction and maintenance over time. It is the first time the Index - now called "NHCCI 2.0" - has been published since the agency made major methodological revisions to improve its accuracy. The latest figures show that highway construction costs today have climbed by 67 percent compared to similar costs in 2003, with key highway components such as asphalt, concrete and metal, increasing at 107 percent, 61 percent and 45 percent, respectively, between 2003 and 2016.

6. The House of Representatives was scheduled to vote Monday on legislation that would expand the educational benefits to veterans under the GI Bill. An identical companion bill was introduced last week in the Senate.

7. According to a recent report on National Public Radio, Supreme Court Justice

Anthony Kennedy has let his clerk applicants for the 2018-2019 term (which begins in October 2018) know he is considering retirement. Justice Kennedy - who turned 81 yesterday - was appointed to the court by President Reagan in 1988.

8. This weekend, July 29 and 30, a number of big DC names will travel to California for the 3rd annual Politicon at the Pasadena Convention Center. Brand new White House Communications Director Anthony Scaramucci will be a panelist, along with folks like The Weekly Standard editor at large Bill Kristol, former Trump advisor Roger Stone, former RNC Chair Michael Steele, and former Clinton advisor Paul Begala.

From the Editor

Shoes ... Ahhh, Shoes!

As the youngest of eight girls, we wore and shared shoes and passed them up and down. It didn't really matter if they were a good fit, especially our Sunday and dress-up shoes. We only wore them once or twice a month and as growing children, we made them fit. In other words, we squeezed our heels and toes into them and made it work. When they were too big, we stuffed paper and socks in the toes and made them fit.

Shoes make for interesting conversation. I have heard people say: "If the shoes don't fit, don't wear them." So often we say and hear interesting things. Even when our shoes didn't fit, we *had to* wear them. As a result, many of us have "bad" feet today, including me. Even though the concept didn't work for my feet, it works out very well in life. When people say things, make judgements and assumptions, I decided some time ago when things apply to me and when they do not. When the spoken words or actions don't apply to who I am, I don't put those *shoes* on my feet. I think the world would be a better place if we would stop trying to wear other folks' shoes.

We are each different and unique. We should NOT enjoy the same food, clothing, personality types, seasons, cars, pets, destinations, books, or hobbies. These differences are the things that make us so wonderful and diverse. When we yield to what others want us to be rather than who we really are, we are never happy. Unhappiness is the result of trying to fit our feet in other people's shoes.

Life nor people are perfect, so the fit might not be perfect, but it should be comfortable. During a time when everybody is worried about what everybody else is doing or not doing, I have a piece of old fashioned advice: "If the shoe doesn't fit, don't try to wear it."

As I work on this iPad tonight, I am concerned about the children who are physically challenged with typing, visually challenged with reading from the screen of a computer, pad or mobile device and those of us who just don't fit with being forced to be like everyone else. I worry about elders whose shoes don't fit due to the change in bone structure of the feet with age but due to limited resources are unable to get ones that fit. I worry about people who have insurance but are thrown out of health care facilities because the insurance company dictates the length of your stay. I worry about doctors and professionals who want to do the right thing, but are challenged with the "rules". I worry about "good decent people" remaining silent when they see and know that things are wrong.

Even with our worries and concerns, we know how to manage them. With a deep and healthy faith, eternal optimism, and many great examples of goodness we remain focused on tomorrow. Yesterday, I celebrated another birthday. I have decided to get me a new pair of shoes--a pair that fits. For some reason, all of my shoes seem to hurt my feet. I wonder if it's due to other folks' shoes or because I worry about so many things that I can not change, like iPads, elders and health care.

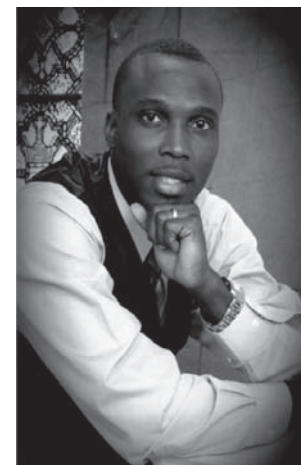
Samford chose Pastor Leatherwood for this venture because he exemplifies excellence in his service to God, to family, and to the theological education of his community.

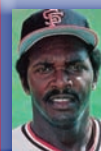

Documentary Underway Will Show Ed Sullivan's Role in Civil Rights

A documentary scheduled for release in 2018 will celebrate Ed Sullivan's subtle role in bringing about positive change in the Civil Rights Movement.

The brainchild of Sullivan's granddaughter (Margo Precht Speciale) and Diahann Carroll's daughter Suzanne Carroll, the film--"Sullivision: Ed Sullivan and the Struggle for Civil Rights"--will delve into Sullivan's role in providing exposure to black artists during times of segregation and racial turmoil.

Harry Belafonte: "It is one thing to look at the transformation of the United States of America through the prism of what Dr. King brought to the table. But the Civil Rights Movement would never have been able to sustain itself with the intensity that it did if there were not subtle forces at play. That subtle force was...Ed Sullivan."

"Sullivision" is a 70-minute documentary taking a surprising look at a man who was once television's most influential personality.

Ed Sullivan is known for creating the longest running variety show and introducing the Beatles to America. What most people don't know is that he was also a risk-taker who booked African-American



artists despite threats from Southern sponsors and numerous letters from irate white viewers.

Sullivan showcased acts audiences had never heard of that are household names today — and he treated these artists with grace and dignity back when racism was normal and insidious, challenging America to do the same.

This film tells the story of a man who changed the face of popular culture and the performers and viewers whose lives were deeply impacted by the show.

Based on interviews with celebrities and Sullivan's family members, as well as media analysts, the documentary brings to light a little known chapter in America's struggle for racial justice.

The old Grissom High School will be repurposed for a south Huntsville community center after it changes from Huntsville City School System to City of Huntsville ownership.

The proposed Sandra Moon Community Complex, named after the late former councilwoman pending Council approval, will also be the anchor for the new Baily Cove Library.

This new library will feature wi-fi, computer areas, and ample space far surpassing the space of the current facility.

Additionally, the local arts community, via Arts



Huntsville, will make use of the areas of the old school that related to theatre and fine arts.

The old school's gym and sports areas will be assigned to Huntsville Parks and Recreation.

Ownership of the property should be settled in August, while working the facility into the city's budgeting process for renovations and other demolition needs will likely occur in September for the next fiscal year..

Everything You Ever Wanted to Know about Yard Waste

- First of all, containers must be designed for residential waste collection and placed at the curb by 7 a.m.
- Place boxes, furniture, appliances, household items, tree limbs, junk, and yard waste out for trash collection. All trash or yard waste that is able to fit into a container must be placed in one before it will be collected
- All building material such as planks, boards, siding, and the like, which is the result of home improvements the homeowner has done must be placed in a con-



- tainer for collection.
- Containers must not be blocked by vehicles, vegetation or other obstructions, exceed 32 gallons, or weigh more than 50 pounds.
- Yard waste such as grass, leaves, edge and shrubbery clippings, and building material must be placed in 32 gallon cans or bags and cannot weigh more than 50 pounds.
- Tree limbs should not exceed 5 feet in length. Tree limbs up to 10 cubic yards will be collected at no charge, with each additional 5 cubic yards costing \$45 per collection.
- Place all trash items behind the curb for collection. Do not place any

- debris in the road, gutter, on top of storm drains, on sidewalks, or next to utility lines/poles/boxes.
- Containers must not contain debris other than trash or yard waste or unacceptable or hazardous waste such as paint, chemicals, solvents, dead animals, medical or biological waste.
- Common items that are not collected by the City include dirt, rocks, bricks, cinderblocks, shingles, or concrete; tree limbs or trimmings resulting from land clearing.
- The City will not pick up construction debris or any debris resulting from a contractor's work or commercial project.
