Washington in One Minute



Here are the happenings in Washington, D.C., this week: 1. ON THE FLOOR. The House and Senate are in session this week. The Senate will resume consideration of the \$52 billion CHIPS Act to jumpstart the domestic semiconductor industry and may also take up a bill that requires the federal government to recognize same-sex and interracial marriages, which passed the House last week by on a bipartisan vote of 267 to 157. The House has a long list of bills on its calendar this week, including legislation to clear federal roadblocks to allow an expanded research process for FDA-approved marijuana-derived medications to be used to treat serious medical conditions and a bill to shut down "roadside petting zoos" for lions, tigers, leopards, cheetahs, jaguars, cougars, and their hybrids and to prohibit private ownership of these big cats. The House may also take up a bill to ban assault weapons that was approved by the House Judiciary Commit-

tee last week on a 25-18 vote and the Senate-passed version of the CHIPS Act. 2. THE WHITE HOUSE. Last Thursday, President Biden announced that he tested positive for the coronavirus and canceled a scheduled trip that day to Wilkes-Barre and Philadelphia, PA to tout his new \$37 billion anti-crime initiative and a trip to Orlando and Tampa, FL today (Monday) to address the National Organization of Black Law Enforcement **Executives Annual Conference** and speak at a Democratic rally. The White House announced last week that the

President likely has the BA.5 variant and will isolate in the White House through at least Tuesday. On Monday, Vice President Harris traveled to Indianapolis, where she met with state legislators to discuss the fight to protect reproductive rights, coinciding with the beginning of the Indiana General Assembly's special session, where lawmakers will consider bills that ban abortion, among other issues.

3. JANUARY 6 COMMIT-TEE. According to Friday's Washington Post, nearly 17.7 million television viewers tuned in last Thursday night to the House Jan. 6 Committee's 2nd prime time hearing. The number, measured by Neilsen Media Research, encompasses 10 broadcast and cable networks and represents a slight drop from the more than 20 million people who watched the first prime time hearing in June. Vice Chair Liz Cheney (R-WY) - standing in for COVID-positive Chair Bennie Thompson (D-MS) announced that the committee would return in September with more hearings.

4. ELECTORAL COUNT ACT. Last week, following months of bipartisan negotiations in response to the events of January 6, 2021, Sens. Susan Collins (R-ME) and Joe Manchin (D-W.Va.) introduced the Electoral Count Act to reform the Electoral Count Act of 1887 to: (1) clarify that a sitting vice president has only a ministerial role when Congress

convenes to certify the results of a presidential election and has no authority to overturn the results; (2) require at least one-fifth of the membership of each chamber of Congress to lodge an objection to any state's slate of electors; and (3) clarify that state governors are responsible for submitting certificates identifying slates of electors unless state law specifies otherwise. Bill proponents aim to get the bill passed before the November 2022 elections.

5. MONKEYPOX. With U.S.

cases of monkeypox as of Friday at 2,600, last week 50 Members of Congress signed a letter asking the President to declare the monkeypox outbreak a public health emergency and allocate the millions of Jynneos vaccine doses in the U.S.' current supply. In addition, Senate Health, Education, Labor and Pensions Committee Chair Patty Murray (D-WA) and House Committee on Oversight and Reform Chair Carolyn Maloney wrote to HHS Secretary Xavier Becerra asking him to brief Congress on the Administration's response to the disease outbreak. The HHS Department has put out a fact sheet on monkeypox (read it here: fact sheet), saying it has distributed around 200,000 Jynneos vaccines so far and is expecting roughly 800,000 more later this summer and has raised testing capability to 80,000 tests per week. On Saturday, the World Health Organization declared monkeypox a public health emergency, with 75 countries reporting a total of 16,000 cases (a five-fold increase since June).

6. CHIPS BILL/SHORT-TERM PELL. On Monday, the Senate held a cloture vote on the CHIPS-Plus bill, a \$280 billion package designed to boost both domestic semiconductor chip manufacturing and U.S. high-tech research. The

problems were anticipated with cloture. Senate leadership said the bill wwould pass no later than Wednesday. After recent negotiation between the parties, Senate Democrats decided to move forward with a much smaller bill that is centered around support for semiconductor manufacturing. Other provisions have been added to the "CHIPS" bill but none of the education provisions, including short-term Pell. The development is a significant setback for community colleges since the competition bill was the most likely legislative vehicle to enact short-term Pell before the end of the cur-

legislation had strong support

from GOP members, so no

rent Congress. Congressional Democrats have indicated a desire to continue negotiating on the provisions that were not included in the CHIPS bill, but further action in that area as unlikely.


I leave with you; my peace I give you, I do not give as the world gives . So let not your hearts be troubled and do not be afraid.

BLACK MEN: Lowering the Odds of Prostate Cancer

Genes can put some men, especially Black men, at heightened risk of prostate cancer. The good news, however, is that a new study suggests that there may be ways to undo much of that potential harm with a healthy lifestyle.

Researchers found that among men at increased genetic risk of prostate cancer, those who maintained a healthy lifestyle were much less likely to die of the disease over nearly three decades.

"Healthy" meant they exercised regularly, refrained from smoking, kept their weight down and favored fish over processed meat.

Men who met those goals had a 1.6% lifetime risk of dying from prostate cancer.

That compared with a 5.3% chance among their counterparts with unhealthy habits, the investigators found.

However, healthy habits did not appear to protect men from developing prostate cancer in the first place, lead researcher Dr. Adam Kibel notes.

It's possible they instead lower the risk of aggressive prostate cancer, according to Kibel, chief of urology at Brigham and Women's Hospital, in Boston.

Prostate cancer is very common: About one in eight men will be diagnosed with the disease in their lifetime, according to the American Cancer Society (ACS). But the cancer is often slow-growing, and may never progress to the point of threatening a man's life: Only one in every 41 men actually die of prostate cancer.

So although you may not be able to exercise your risk of the disease away, lifestyle may matter in the aggressiveness of the cancer.

"One way to look at it is, an unhealthy lifestyle might throw fuel onto the fire," Kibel adds.

Of the 12,000 men surveyed, each man was given a healthy lifestyle score, earning one point for each of six factors: keeping their weight below the obesity cutoff; regularly getting vigorous exercise, like jogging; not smoking; regularly eating fatty fish (like salmon); eating tomato products; and limiting processed meats. In particular, studies have tied

those three diet habits to a lower risk of prostate cancer or death from the disease.

Over 27 years, just over 3,000 men developed prostate cancer, and 435 died from it. Genes made a big difference: Men with genetic risk scores in the top 25% were over four times more likely to die of the disease, versus those in the bottom 25%, the investigators found.

But for those same men, lifestyle also had a big impact. Those who stuck with at least four of the six healthy lifestyle factors cut their odds of dying from prostate cancer by 45%, versus men who adhered to few or none.

The statue of this HBCU founder, civil and women's rights activist replaced Confederate general Edmund Kirby Smith's.

victorious struggle for human rights and HBCU advocacy.

Born the 15th of 17 children to former slaves Bethune took five girls, her son Albert, and \$1.50 and found HBCU's Bethune-Cookman College (now University) in 1904, one of the first woman college presidents at that time.

In 1938, when he appointed her the Negro Affairs director of the Great Depression's National Youth Administration, President Franklin Roosevelt made her the first Black woman to head a federal agency.

Fittingly, her new Capital Hill statue is inscribed with one of her favorite sayings: "Invest in the human soul. Who knows? It might be a diamond in the rough."

In what ways are you and I preparing the next round of #BlackGirlMagic-ians? They might not become a Statuary Hall honoree but they can certainly tower over their circumstances.

Perhaps that's what Jesus was forecasting for his followers - like Mary McLeod Bethune.

In His humanity, His struggle with the will of God was real and proved to be redemptive when He relinquished His own will for that of His Father.



The writer of Hebrews recorded that Jesus is our Great High Priest who sits upon the throne of grace with present help available to every believer because He identifies, with empathetic awareness, with the weaknesses of those who call on Him.

It is Jesus' familiarity with Gethsemane that served Him in His hour of need.

It is the believer's familiarity with Gethsemane that helps him/ her develop the same kind of trust that Jesus displayed.
