

HHHS Names VP for Women and Children's Services

Kyle Buchanan, who has held several key leadership roles for Huntsville Hospital Health System, is the new Vice President of Women and Children's Services.

Buchanan replaces Paula Lucas, who retired after making Women & Children a launching pad for new, first-in-the-region clinical services including the St. Jude Affiliate Clinic, OB Emergency Department and Pediatric ER. Lucas was also instrumental in starting the Wellness Centers.

"Sometimes one walks into a new leadership role to face fires on every corner," Buchanan said. "This is the exact opposite. First, Paula's leadership has been fantastic. Additionally, the medical staff is phenomenal and the staff is rock solid."

A Tuscumbia native, Buchanan joined the Health System in 2009 as vice president of operations at Helen Keller Hospital

and later served as CEO of Lawrence Medical Center, a 98-bed hospital in Moulton. For the past couple of years, he has been executive director of the Health System's Population Health efforts, which provides chronic disease management services for about 48,000 Medicaid recipients and 12,800 Medicare recipients.

Buchanan graduated from the University of Alabama with a bachelor's degree in business and earned master's degrees in health services administration from the University of Michigan and business administration from UAB. - HunstvilleHospital.org

Here are the happenings in Washington, D.C., this week:

- 1. The Senate is in session this week. The House is in recess until September 4. After 7 GOP Senators failed to show up last week (including Sens. Mike Lee of Utah and Thom Tillis of North Carolina who had first called for the cancellation of the August recess back in May), Senate Majority Leader Mitch Mc-Connell (R-KY) called votes to confirm 2 federal judges and sent everybody home on Thursday afternoon, one day after convening on Wednesday. Because of the lack of Senators, the Senate did not take up a package containing the FY19 Labor/HHS and FY19 Defense appropriations bills, on which it was expected to begin debate Monday.
- 2. Also on Monday, President Trump hosted a "Salute to Heroes" to honor agents from the Immigration & Customs Enforcement (ICE) and Customs & Border Protection agencies. Tuesday, he traveled to Charleston, W.V., to announce a revamped plan to allow states to set emission standards for coal-fired power plants that will significantly roll back an Obama era rulemaking, which was intended to retire most of the 300 coalfired plants in the U.S. and cut CO2 emissions by 19% by 2030. The Trump Administration plan reportedly will provide an incentive to keep coal plants in operation and may only cut emissions by 0.7%. On Wednesday, he awarded a posthumous Medal of Honor to Air Force Technical Sgt. John Chapman who was killed

in action in Afghanistan in 2002. On Friday, the President traveled to Columbus, Ohio, to keynote the 2018 Ohio Republican Party State Dinner. While in Ohio, he also attended a fundraiser for GOP Senate candidate Rep. Jim Renacci.

- 3. Jurors on Monday in the Paul Manafort trial resumed their deliberations for Day #3 on former Trump Campaign Chair Manafort's 18 counts of bank and tax fraud in the first case that Special Counsel Robert Mueller has brought to trial as part of his wide-ranging probe of 2016 Russian election interference. Last Friday, Judge T.S. Ellis turned down a motion from journalists to release the names of the jurors at the end of the trial, citing a need to protect their "peace and safety."
- 4. According to The New York Times, last Thursday White House Chief of Staff John Kelly, after hearing reports of a \$92 million price tag, ordered the Pentagon to issue a statement delaying until 2019 President Trump's military parade that had been planned for Veterans Day. On Friday, President Trump announced that he would instead attend a parade in Paris to commemorate the 100th anniversary of the World War I armistice on November 11 and another parade at Joint Base Andrews in Maryland. Last week, the 2.4 millionmember American Legion issued a statement that the parade's \$92 million cost would be better spent on American

troops and their families.

- 5. Last Thursday, the Department of Education's Office of Civil Rights announced that it was launching an investigation into how Ohio State University (OSU) is conducting its probe of the sexual abuse allegations against deceased former team doctor Richard Strauss, who is accused of abusing more than 100 OSU athletes. Former OSU Assistant Wrestling Coach Rep. Jim Jordan (R-OH) - about whom questions have been raised as to whether he knew of the allegations - has leveled a charge of bias against the law firm investigating the abuse allegations, Perkins Coie, calling it "Hillary Clinton's law firm."
- 6. U.S. Citizenship and Immigration Services clarified its reporting requirements related to a work program for foreign students in the fields of science, technology, engineering, and math. The updated webpage deals with international students whose employment situation changes while enrolled in "optional practical training." The program allows students in STEM fields to apply for up to 36 months of work authorization related to their education.
- 7. Last week, The Cook Political Report, Washington's most influential political prognosticator, predicted that there are now 37 GOP House seats which they rate as "toss ups or worse," including 10 that "lean Democratic." This is up from January 2018, when Cook had only 20 GOP seats rated as toss ups. The newest GOP toss ups are Rep. Mimi Walters (R-CA), Rep. Tom MacArthur (R-NJ) and an open seat in North Carolina soon to be vacated by Rep. Pittenger, who lost his primary. House Democrats need 23 seats to take control of the House next year.

Spotlight on Our Elders ... Featuring

Charles "Chuck" Richard Vedane

Charles "Chuck" Richard Vedane was born December 6, 1934, on a farm south of Lewis, Iowa, one of the three sons of Victor & Della Vedane. "Chuck" Vedane graduated from Menlo High School in May 1952 and set out operating a farm adjacent to his parents. By 1953, he was drafted into the U.S. Army and took basic training and anti-aircraft artillery radar operations training at Ft. Bliss, Tex. Following this intense training, Vedane was assigned to a base outside of Niagara Falls, N.Y.

From 1955-58, Vedane entered St. Louis University's Parks College of Aeronautical Technology, from which he graduated with a B.S. in aeronautics, and he secured an airframe and engine license, and a private pilot's license.

Vedane's productive career includes extensive stints with the Army Ballistic Missile

Command in Huntsville, Ala., where he was responsible for systems testing of Jupiter

and Jupiter R&D ICBMs; Marshall Space Flight Center, where he tested Mercury Redstone 1 & 2 and the early Saturn 1 vehicles; Teledyne Brown Engineering, where he organized and managed a Space Operations Department


that would eventually employ about 220 people.

As a member of Trinity Methodist Church, Vedane in 1963 became involved in church and community affairs in response to the racial strife throughout the nation. He prepared a letter from Trinity's Sunday School Class to the newly elected Governor George C. Wallace informing him that the Governor's

historic "stand in the schoolhouse door" at the University of Alabama was not approved of. This decision has led to more than 50 years of work within the interfaith religious community to promote better relations across

religious, racial, and cultural differences.

Vedane, who ran for Huntsville mayor in 1976, has been actively involved in a number of other volunteer efforts, as well. Vedane and his late wife Lucy had two sons (Scott and Kyle) and a daughter (Rebecca).


