Nation Mourns Death of Justice Ginsburg

The 87-year-old iconic Justice Ruth Bader Ginsburg died at her Washington, D.C., home on Friday, September 18, from complications from metastatic cancer of the pancreas. Her death initiating a league of reflections on her productive role on the U.S. Supreme Court.

In more recent years, Ginsburg became known as a mainstay for a larger-than-life legal, cultural and feminist figure. The Brooklyn native is credited for opening several doors that had been closed because of sex discrimination and other injustices.

Drake State Opens Northwoods Facility

Drake State Community & Technical College has recently partnered with the Huntsville Housing Authority for the grand opening of an adult education learning center in the Northwoods public housing community.

HHA generously offered up one of its apartments to be converted into an adult classroom. After a recent grand opening, adult education students can now learn closer to home, and the program is completely free. This is Drake State's second off-site adult education classroom. The other site is located at Asbury Church in

Madison.

"We can reach students who may live with a disability, students who are low income, and students who don't have jobs but want to get their GED or get a better education," said Adult Education Director Dr. Doquinn Taylor. "They don't have to worry about traveling to the main campus. They can easily walk right outside their homes."

For some adults, the challenges of going back to school can feel like a balanc-

ing act. They have to juggle between family life, childcare, job and financial responsibilities. Drake State's adult education program is helping students by alleviating some of those burdens.

Dr. Taylor said partnerships are important because they can do a lot for students who may need assistance with transportation or someone to care after their children.



"Often times we hear, 'I didn't know about these services,'" said Dr. Taylor. "Thanks to our partners, we're bringing these services directly to the community so residents can take advantage of educational opportunities."

LWV Launches Voting Series

The League of Women Voters of the Tennessee Valley has launched a weekly series of video shorts highlighting some of the key issues around voting in Alabama.

The shorts will address registering to vote, the importance of voting, debunking common excuses not to vote, absentee voting, and volunteering at the polls.

The series kicked off on National Voter Registration Day, Tuesday, September 22. A new short will air every Tuesday until Elec-

tion Day.

Some of these include: Commissioned 2nd Lieutenant in the United States Army and discharged as Captain in 1967; Award for the design and fabrication of an oral/nasal obturator to treat patients who had a cleft palate (to prevent food from going into the nasal cavity); and voted

one of five (5) most outstanding African Americans in the City of Huntsville on two (2) separate occasions.

His civic and professional affiliations include: member, Madison County Dental Society; member, Academy of General Dentistry; member, America Academy of Implant Dentistry; member, Alabama Academy of General Dentistry; charter member of Phoenix Group, an interceptive group designed to prevent delinquent/troubled youths from incarceration; life member, National Association for the Advancement of Colored People (NAACP); and member Kappa Alpha Psi Fraternity, Inc.

has served as a member of the Board of Directors of Huntsville Hospital Dental Board; Board of Director, Central North Alabama Health Systems Agency, and Dental Representative, Head Start North Alabama Region. Dr. Scott is married to Mrs. Eunice Betts Scott, and they are the proud parents of three.

SEPTEMBER 25 - WILL SMITH - Born in West Philadelphia. He has had a successful career in television, film and music. A rare feat called "Triple Threat" in the industry. He is the only black actor and one of three actors in the history of film to have seven consecutive US\$100 million blockbusters.

"Vapid Vocality"

Genesis 19:12-14

The word *vapid* is defined as *offering nothing that is stimulating or challenging*. There are certain scenarios where this may be the case. It could be a *motivational speaker* who is so in name only. Unfortunately, it happens in pulpits, as well.

The late James Brown put it quite succinctly in

his song entitled, *Talking Loud and Saying Nothing*. The text is the story of Lot giving his family a weightless warning about the destruction of the city in which they lived. They thought he was joking. *Vapid vocality!*

As I wrote this, I was watching scenes of the motorcade of Congressman John Lewis' trek to



the nation's capital to lie in state at the rotunda for two days. The irony of this event was that while his colleagues on both sides of the political aisle

were honoring him, some of their speeches were examples of vapid vocality because they do not practice even what they "say" Representative Lewis stood for. Juxtaposed to the congressman's words, there is the physical absence of the one who represents the highest office in the land who, like Lot in the text, in the midst of the warnings of death and destruction because of COVID-19, gives words of false hope and wishful thinking. Congressman Lewis' words are just the

opposite. His *good trouble* mantra was more than verbiage. It was valid and verifiable. It was the

Washington in One Minute



Here are the happenings in Washington, D.C., this week:

The House and Senate are in session this week.

1. Both bodies are expected to take up a temporary funding bill to keep the federal government open on October 1 when Fiscal Year 2021 starts (in lieu of the 12 annual appropriations bills which are not finished). The bill will fund all government

agencies at FY2020 levels through December 11, 2020, and reportedly will also provide an additional \$30 billion for aid to farmers and \$2.7 billion to provide school meals for low-income children eligible for free- and reduced-price lunches, but who aren't in school to receive them. Politico reports that Rep. Jaime Herrera Beutler (R-WA) has filed a discharge petition (which requires 218 signatures) to attempt

to force a vote in the House on a stand-alone extension of Paycheck Protection Program (PPP) loans. If all 198 GOPers signed on, she'd need 20 Democrats to join.

2. On Monday, President Trump traveled to Ohio for campaign events at the Dayton International Airport and at the Toledo Express Airport. On Tuesday, he visited the Pittsburgh International Airport (PA) for a campaign event. On Wednesday, the President spoke at an event with the Bay of Pigs Veterans Association, which has endorsed his campaign, and hosted a meeting with state attorneys general on the topic of social media. On Thursday, he visited Cecil Airport in Jacksonville, Fla., for a campaign event.

3. The New York Times

reported on Sunday that the body of Supreme Court Justice Ruth Bader Ginsburg, who passed away at 87 on Friday from complications of pancreatic cancer, is expected to lie in repose for an unprecedented two days at the Supreme Court this week, due to expected large crowds. A small funeral service is also expected to be held for Justice Ginsburg, as well as a burial at Arlington National Cemetery later in the week. President Trump this week is expected to name his choice to replace Justice Ginsburg and NBC News reports that leading candidates are: 7th Circuit Federal Appellate Judge Amy Coney Barrett, 4th Circuit Federal Appellate Judge Allison Rushing, and 11th Circuit Federal Appellate Judge Barbara Lagoa. Axios reported that the

Democrats' online fundraising platform ActBlue received a record \$91.4 million in donations in the 28 hours following Justice Ginsburg's death on Friday.

4. Federal Reserve Chair Jerome Powell appeared at two hearings this week on the status of coronavirus relief: on Wednesday at 10 a.m. EDT before the House Select Subcommittee on the Coronavirus Crisis and Thursday at 10 am EDT before the Senate Banking Committee (along with Treasury Secretary Steven Mnuchin).

5. On Friday, the Internal Revenue Service and Treasury Department published final rules on the endowment tax that was included in the Tax Cuts and Jobs Act signed into law in 2017. Although, higher education advocates still oppose the tax, they

indicated that the final rules made improvements to the interim rules. The law created a 1.4 percent excise tax on net investments income at private colleges and universities with at least 500 tuition-paying students and assets of at least \$500,000 per student. In a reversal, the Treasury and IRS will not count a student whose tuition is paid through federal grants, scholarships or institutional aid as a tuition-paying student.

November's "Olympics": A White House Sprint vs. a U.S. Senate Marathon?

"Is there anyone here who, planning to build a new house, doesn't first sit down and figure the cost so you'll know if you can complete it? If you only get the foundation laid and then run out of money, you're going to look pretty foolish. Everyone passing by will poke fun at you: 'He started something he couldn't finish'"

In this passage, Jesus counseled listeners to complete what they'd started.

"Dollar Tree" Wisdom

I visited Dollar Tree recently to purchase AA batteries. When I saw displayed upfront AA four-packs, I was about to grab three and head for checkout. With a little more searching, however, I discovered two almost-hidden AA six-packs.

I replaced the three four-packs for two six-packs, giving me the same 12 batteries. With a little more diligence, I saved both some grocery monies and learned a "Dollar Tree" object lesson concerning this November's presidential and senatorial elections:

Our quicker more attractive grab would be just a White House four-pack (a four-year presidential sprint), but the better value is the U.S. Senate six-pack (a six-year Senate seat marathon).

A re-elected six-year Senate term = three White House stays, for which a president is term-limited to just two.

Do the Math!

Most of our attention is riveted on 2020's quadrennial presidential "beauty contest" sprint; however, smarter strategists recommend investing in the sexennial U.S. Senate marathon.

Although the American majority was pleased electing its 1st Black president (sprint), the GOP-controlled Senate thwarted Barack Obama's 2nd-term initiatives for key legislation and longer-term judicial appointments (marathon).

While a "yes-and" strategy (White House-Senate majority) may be ideal, if forced to choose, an "either-or" Senate marathon run is better political wisdom.

Jazz and Golf Out of Huntsville

Since our country is presenting our national championship, I thought it would be fitting to share this experience.

I am pleased to share that when the USGA awarded grants to youth programs, over five years, my various programs, including Tennessee Valley Jazz Youth Golf Development-Huntsville, and The First Tee of Huntsville, were awarded several grants. I'm a grant writer for my programs, and at the time when the USGA offered grants, they were some of the most challenging grants to apply for and be awarded. I'm not boasting, just sharing how rare my golfing experience as a Black man is. At the time, the USGA didn't allow non-USGA officials to use the logo. I suggested for marketing and credit purposes for the USGA to create and approve the use of the USGA logo for programs they funded ... While I'm at it, we were awarded several PGA grants as well.

We were the first program in Alabama to receive the USGA grants. You'll be surprised by the jealousy I received from black golfers in the area. Many of the white European Americans hated me too. But I have a few that did and still support my program today.

Big thanks to my youth participants and families, Dr. Michael Cooper, Steve Mack, Dr. Lee Gradford, Earnie Ellison, Judy Bell, and Debert Cook for believing in me.
