Delta Chapter Will Step Up for the Elderly

The Central North Alabama Alumnae Chapter of Delta Sigma Theta Sorority, Incorporated, calls for a public hearing with the Decatur (Ala.) Housing Authority Directors, Board Chair and Members, and the Mayor of Decatur to specifically address the concerns of the citizens of Decatur regarding the Housing Authorities' disparate treatment of its African-American senior residents.

The chapter, represented by its president, Judise Lanier, expressed its disappointment in the findings of the Department of Housing and Urban Development that the Decatur Housing Authority maintained discriminatory housing practices in its senior properties, at the September 28 special Decatur City Council call meeting.

Lanier stated, "We understand that the Department of Housing and Urban Development reached a settlement with the Decatur Housing Authority to redress the issue of disparate treat-

ment against its African-American residents. That is simply not enough. There is no accountability nor controls to correct the culture of discrimination with the Decatur Housing Authority."

At the September 28 meeting, the Decatur City Council voted to invite the Decatur Housing Authority Board members, Housing Authority directors and the Mayor to a public hearing.

That hearing had been set for Thursday, October 15, 2020, but it has been rescheduled.

While the members of the Decatur Housing Authority are not required to attend, it is the hope of



the chapter that they are present.

"We are convinced this meeting with the public will spark a new, productive, beneficial and transparent relationship between the board and the community it serves," stated Lanier.

The thought-provoking poetry of local poet Carey Link has been published by Blue Light Press and is now collected in "Through the Kaleidoscope."

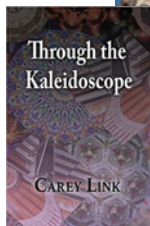
"It's difficult to do justice to Link's exquisite poetry" commented Susan Luther, poet and author of "Breathing in the Dark."

Hall also received a business education certificate from Manpower in 1963. She was later employed by Marshall Space Flight Center, where she was a Documentation Analyst for over 18 years.

A lifelong member of Center Grove United Methodist Church, Hall served in various ministry areas, including Chancel Choir member, pres-

ident of United Methodist Women, chairperson and co-chairperson of the Harvest Committee, chairperson of King's Care, chairperson of Stewardship, member of the Finance Committee, and chairperson of Burns-Northside, to name a few.

In 1978, she established the first Mother-Daughter Luncheon at Center Grove United Methodist Church. She also served in various civic organizations in her community that include member, Elk Lodge #977 (Daughter of Elk); member, Corner's Homemaker and Community Club; member, ABWA (American Business Women Association); member, Red Hatters (Hill Top-Rough Chapeaux); and member, Eta Phi Beta Soror-



ity, Inc.

Hall's greatest joy in life was caring for the sick and underprivileged, and her adopted motto was, "Let My Work Speak For Me." Her work has spoken, and it is still speaking for her through the tireless care she gave to her family and friends. She always made herself available to assist others.

"Vapid Vocality"

Genesis 19:12-14

The word *vapid* is defined as *offering nothing that is stimulating or challenging*.

There are certain scenarios where this may be the case. It could be a *motivational speaker* who is so in name only.

Unfortunately, it happens in pulpits as well. The late James Brown put it quite succinctly in his song entitled, *Talking Loud and Saying Nothing*.

The text is the story of Lot

giving his family a weightless warning about the destruction of the city in which they lived. They thought he was joking. *Vapid vocality!*

As I write this, I am watching scenes of the motorcade of Congressman John Lewis' trek to the nation's capital to lie in state at the rotunda for two days.


The irony of this event is that while his colleagues on both sides of the political aisle are honoring him, some of



their speeches are examples of vapid vocality because they do not practice even what they "say" Representative Lewis stood for.

Juxtaposed to the congressman's words, there is the physical absence of the one who represents the highest office in the land who like Lot

Washington in One Minute



Here are the happenings in Washington, D.C., this week:

1. The House and Senate are in recess this week, although the Senate Judiciary Committee started four (4) days of hearings on Monday on the nomination of Judge Amy Coney Barrett to replace the late Justice Ruth Bader Ginsburg on the Supreme Court.

The hearing began at 9:00 a.m. EDT. Talks between Capitol Hill leaders and the Trump Administration on a new coronavirus relief bill reportedly will continue this week, despite an almost full stop on the bill's progress due to thoroughly negative reviews of the Administration's \$1.8 trillion compromise bill from both GOP senators and the House Democratic leadership over the weekend.

Late Sunday, The Washington Post reported that White House Chief of Staff

Mark Meadows and Treasury Secretary Steven Mnuchin sent a letter to Congress asking lawmakers to pass a narrow bill allowing the Trump Administration to redirect about \$130 billion in unused funding from the Paycheck Protection Program to initiate a second round of loans under the program, while negotiations continue on the broader relief effort.

2. President Trump resumed his campaign travel this week, with rallies held Monday in Sanford, Fla., at the Orlando Sanford International Airport; Tuesday in Johnstown, Pa., at the John Murtha Johnstown-Cambria County Airport; and Wednesday in Des Moines, Ia., at the Des Moines International Airport.

Former Vice President Joe Biden was in Ohio Monday for an afternoon campaign speech in Toledo and a get-out-the-vote event in Cincinnati. On Thursday, Mr. Biden took part in a

televised town hall hosted by ABC News, in place of the 2nd Presidential Debate scheduled for Thursday that was cancelled by the Commission on Presidential Debates. Variety reported last Friday that NBC News is among the news outlets exploring the possibility of holding a town hall with President Trump that was scheduled for the same night (Oct. 15).

3. Last Thursday, the U.S. Supreme Court declined the Trump Administration's petition to reverse a Maryland federal judge who ruled in July 2020 that a nationwide Food and Drug Administration (FDA) directive requiring an in-person visit to a doctor's office or clinic to obtain the medications needed to induce abortion was unduly burdensome during the coronavirus pandemic.

The unsigned order was strongly opposed in a dissent written by conservative Justice Samuel Alito and joined by Justice Clarence Thomas, who claimed that the lower court was using the coronavirus as an excuse to expand abortion rights.

In 2016, the FDA eliminated the requirement that the abortion drug mifepristone be administered in a hospital, clinic or doctor's office, but did not relax the requirement that women

pick up the pills in person and sign for them.

4. The Washington Post reported on Friday that the Wisconsin Democratic Party likely will ask the U.S. Supreme Court to reinstate a plan struck down on Thursday that would have allowed state election officials to receive mail ballots for 6 days after the election (without it, Wisconsin officials may not count any mail ballots that arrive after 8 p.m. on Election Day).

In Pennsylvania, the GOP has already asked the Supreme Court to reverse a ruling by the state's highest court that allows ballots to be counted if they arrive up to 3 days after election day. In both cases, the ballots must be postmarked by Elec-

tion Day. In a separate action last week, the Supreme Court on Monday reinstated a requirement that South Carolina mail voters get a witness signature, saying that federal courts shouldn't overrule elected officials in voting matters and that it is too close to the election to make big changes without confusing voters.

5. On Thursday, the U.S. Justice Department sued Yale University, charging the university with illegal discrimination against Asian American and white applicants. The suit follows through on a threat the Justice Department made to Yale in August directing the university to end consideration of race in admissions or face a lawsuit.

The Department says the university's affirmative action programs discriminate against Asian American and white applicants while favoring Black and Latino applicants. Yale President, Peter Slavoney, maintained that the university's admission process is fair and confirmed that its admission policies will not change because of the lawsuit.

Bathroom Items That Need to Be Tossed

Most bathrooms are chock full of products: things for your body, things for your face, things to clean with, etc.

However, it is unfortunate that some of the ingredients that typically appear in some of the products we use daily — such as shampoo, sunscreen and commercial household cleaners — are best avoided, according to general scientific consensus.

Throw Away: Products With Parabens

Parare, a synthetic preservative and antimicrobial agent commonly found in personal-care products with high water content: shampoo, conditioner, lotion, cleansers and body wash.

They also turn up in solid products like deodorant. They appear as methyl-, ethyl-, butyl- or propylparaben.

Studies have found that parabens mimic estrogen in the body and disrupt normal hormone function, and they have been found in breast-tumor biopsies.

Growing awareness about parabens has inspired a number of manufacturers to banish them in favor of safer preservatives, while some have simply accepted a shorter shelf life as the price of doing healthy business.

You can often find personal-care products labeled "paraben-free," which will save you a little squinting in the product aisle.

Signers of the Compact for Safe Cosmetics have committed to avoiding their use; you can find the list of these companies at <http://www.safecosmetics.org>.

Throw Away: Products With Phthalates

Phthalates are plasticizers that stabilize scent in perfume and color in cosmetics; they also keep nail polish from chipping.

You won't find them listed on most labels, though they can be present in almost every conceivable personal-care item hidden in the ingredient "fragrance." (Company formulas are legally protected as proprietary information.)

Multiple studies have linked phthalates to depression of normal thyroid function and birth defects, mostly affecting the genital development of young boys and sperm counts in adult men.

Two kinds of phthalates commonly found in cosmetics were banned in the EU with its recent cosmetic safety directive, forcing international companies to reformulate their products

for the European market.

A number of nail polish manufacturers have removed the "toxic trio" — dibutyl phthalate, toluene (a solvent and neurotoxin) and formaldehyde — from their nail polish formulas.

Still, it's smart to view nail polish and products with caution, especially if you're pregnant. Water-based polishes are the most benign option.

Throw Away: Products With Sodium Lauryl/Laureth Sulfate (SLS)

SLS is a synthetic detergent and foaming agent connected to skin and eye irritation. It's also linked to the byproduct 1-4 dioxane, a suspected carcinogenic contaminant produced by the ethoxylation process, used to make some ingredients less harsh. (Sodium lauryl sulfate is converted to sodium laureth sulfate, for example.)

Throw Away: Products with Synthetic Fragrances

They can contain as many as 200 ingredients that manufacturers are not required to disclose.

A common allergen, "fragrance" on an ingredient label is a reliable indicator that the product contains phthalates. *-BlackDoctor.org*

Reversing Trump's "Tower of Babel"

A&M Team Encourages Civic Engagement

The Civic Engagement Team (CET) at Alabama A&M University has been increasing efforts aimed at ensuring students take the necessary steps to exercise their voting rights.

In early October, Alabama A&M was among six sites where drive-up absentee voting assistance was provided by Madison County Circuit Clerk Debra Kizer and staffers.

CET recommends that all AAMU students, faculty and staff register to vote in Madison County, confirm their active registration status and head to the Madison County Courthouse.

Registered voters may vote absentee in person at the Madison County Courthouse Monday through Friday from 8:30 a.m. to 4:30 p.m.

According to CET's Dr. Tonya E. Perry, all that is required is a state-issued photo ID, such as a driver's license. Students may use their AAMU ID.

On Thursday and Friday from 8:30 a.m. to 3:30 p.m., buses will run from various campus locations to the Madison County Courthouse to allow the casting of absentee ballots.

CET representatives will be on hand at the Courthouse to support students in completing the voting process.

The last day to vote absentee in person is October 29.
