Your Washington Recap

Here are the top issues in Washington, D.C., this week:

1. The House and Senate are in recess until after the November election. Last week, Senator Bernie Sanders (I-VT) sent a letter to President Obama asking him to halt work on the 1,170-mile, \$3.8 billion Dakota Access pipeline, which will transport approximately 470,000 barrels of oil per day from North Dakota to Illinois. Last week, a federal appeals court ruled against the Standing Rock Sioux Tribe's request to temporarily block the project.

2. President Obama appeared on "The Late Show" with Stephen Colbert, in a skit he taped in Pittsburgh on Thursday after he attended a science and technology conference at Carnegie Mellon University. On Tuesday, he hosted his final state dinner for Italian Prime Minister Matteo Renzi at the White House. Last Friday, NBC News reported that the Obama Administration was preparing a cyber attack on Russia in retaliation for its hack of the Democratic National Committee.

3. The Obama administration announced that the nation's graduation rate for high school students has risen to a record high of 83.2 percent. This year's

rate, measuring students who graduated in 2014-15, is up nearly a full percentage point from the previous year.

4. Last Friday, Senator Elizabeth Warren (D-MA) sent a letter to President Obama asking him to replace Securities and Exchange Commission (SEC) Chair Mary Jo White, citing her continued refusal to disclose their political donations.

5. Last Friday, the FAA issued an emergency order banning all Samsung Galaxy Note7 smartphone devices from air transportation in the United States, effective 12 noon on Saturday, October 15.

6. Under new rules approved by the Treasury and Commerce Departments, U.S. citizens traveling to Cuba will be able to bring back as many as 100 cigars

and several bottles of rum (before they were subject to a \$100 limit). Another change will allow Cuban pharmaceuticals to be marketed and sold in the U.S. after they have received approval from the Food and Drug Administration.

7. 2016 Presidential Watch. The 3rd and final Presidential Debate took place Wednesday (October 19) at the University of Nevada, Las Vegas - moderated by Chris Wallace of Fox News.

Donald Trump held a campaign rally in Green Bay, Wis., traveled to Colorado for rallies in Colorado Springs and Grand Junction. Hillary Clinton surrogates are out in force this week, including two stops in Colorado by Bernie Sanders, a rally in South Florida by President Obama on Thursday and a Pennsylvania event by Vice President Biden held Friday.

“Rocky Horror Picture Show” Comes to Fox

It's almost time to do the time warp again. The cult classic musical is getting the small screen treatment just in time for Halloween. The special, one-night engagement will air on October 20.

The “Rocky Horror Picture Show” production marks Fox's second attempt in introducing live-televised programming to its roster like their rival, NBC. The first was their adaptation of the late 70's classic “Grease”, which featured Julianne Hough, Vanessa Hudgens, and Carly Rae Jepsen.

The 2016 remake will also mark the network's full-fledged adaption of the wacky film. In 2010, the popular musical drama Glee did a tribute episode, featuring the work of the production, titled “The Rocky Horror Glee Show.” Originally, a musical on London's West End, “Rocky Horror” was created to be a lampoon of the science fiction and B-movies of the 1940s. After debut-

ing in 1973, the musical comedy made its way the United States, where it was adapted into the iconic motion picture a mere two years later.

In addition to the film garnering a cult classic following, it also served as one of Oscar-winning actress Susan Sarandon's earlier film roles.

The film follows Brad Major and Janet Weiss, a newly engaged couple who get stranded on a dark, stormy night when their car breaks down.

After embarking a nearby castle, the couple befriends an eerie group of individuals including Dr. Frank-N- Furter, a sinister mad scientist, who claims to have discovered the secret to creating life.

While many fans deem the plot line to be corny, the film is nothing less than a powerhouse for popular culture. Since its 1975 release, the film has unofficially become an integral part of the Halloween season.

Many local theatres and cinemas are known to host re-enactments and shadow performances of the cult classic. Since its release, Rocky Horror is known for the integrated use of callbacks and props that bolster the watching experience.

The 2016 reimagining is directed by Kenny Ortega, who many might recognize for overseeing the “High School Musical” franchise and the Halloween fan-favorite “Hocus Pocus.”

Just like “Grease: Live,” “The Rocky Horror Picture Show” boasts a star-studded cast, featuring the talents of Victoria Justice, Adam Lambert, Ben Vereen, Reeve Carney and Emmy-nominated actress Laverne Cox as Dr. Frank-N-Furter. Tim Curry, who played the original version of Furter is slated to play the Criminologist, the unofficial narrator of the production.

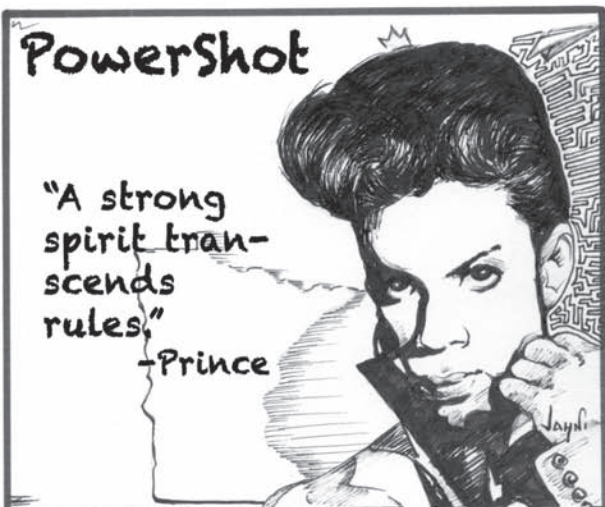

Mayor Delivers 9th State of the City Address

"Smart. Innovative. Collaborative." That was the message Mayor Tommy Battle drove home during his annual State of the City address to a luncheon crowd of 1,000 at the Von Braun Center.

The Mayor highlighted Huntsville's accomplishments during his first two terms in office, and noted the City created 16,000 new jobs and \$2 billion in capital investment in the past five years alone. These impressive figures

are reflected in Huntsville's low unemployment rate of 5.2 percent and respectable budget growth at 3.1 percent.

"We've worked to create an environment where companies can thrive, compete and create jobs – a culture to support a young professional workforce and entrepreneurship," said Battle. "An environment where City Hall knows when to lean in or get out of the way."

Institute Sequencing Beer's "Superwheat"

HudsonAlpha to sequence "superwheat" found in new beer ...

The new beer is made with 15 percent kernza and is marketed by outdoor adventure company Patagonia.

A trendy new beer made with a new wheat variety is connected to work done at the Genome Sequencing Center (GSC) at the HudsonAlpha Institute for Biotechnology in Huntsville.

The center is working with the Land Institute in Salina, Kan., to sequence the kernza genome and apply genomics to improve grain yields for the plant.

Kernza is a sustainable perennial wheatgrass, which means its fields don't have to be cleared and replanted after every harvest.

The grain is also used as an excellent bread flour. The Washington Post called the plant "an ecologist's dream" and Bloomberg said kernza is "solving climate change."

305 8th Street, a faith-based 501(c)3 nonprofit organization that provides a home and family for disabled adults, is making its latest project, Nora's House, a reality, thanks to the generosity of many Huntsville/Madison County community partners.

Construction is scheduled to begin later in October and is set to be completed in spring of 2017.

Nora's House will expand 305 8th Street's services to include eight (8) beds for new residents with disabilities who do

not meet state-waivered requirements and need 24-hour supervision.

"Disabled adults who are denied services based on a point difference in their IQ makes them ineligible for group home care, day services, and direct care, thus leaving a vulnerable population of adults in need," reports executive director Andrea Williams. "Some women on our wait-

ing list have been awaiting placement for over three years."

Currently, 305 8th Street provides 24-hour supervision and care for 15 adults as well as supportive care to five residents living off-site. "For the people on our waiting list, Nora's House is the answer to their

families' prayers, who have nowhere else they can turn to for supportive housing and care," states Williams.
