Niece of Blues Legend Dinah Washington Part of "Women of Alabama" Exhibit

Valley Arts and Entertainment will present "The Women of Alabama Exhibit: A Musical Journey 1900s-2020s."

Obtained by a grant through the Alabama Humanities Foundation and the National Endowment for the Arts, this activity is open to those desiring an intimate and educational music journey.

The event will have a special appearance by Kristin Atkins, niece of the jazz legend Dinah Washington. Washington, born in Tuscaloosa, Ala., and coined "Queen of the Blues," performed with such iconic acts as Count Basie and Duke Ellington.

Preparing for the 2020 General Election

Voters are strongly encouraged to take advantage of the Absentee Voting Process due to COVID-19 and the anticipated historic turnout at polling locations on Election Day. The deadline to request an Absentee Ballot or vote in-person at the Absentee Ballot Office is October 29. The ability to vote an Absentee Ballot due to concern about COVID-19 is legal pursuant to the emergency rule issued through the authority of the Alabama Secretary of State.

The Absentee Office is located in the Madison County Courthouse. It is open each business day - 8:30am to 4:30pm. At the Absentee Office, a voter may apply in-person for, receive, and return his or her own Absentee Ballot; hand-deliver his or her

own completed and sealed Absentee Ballot, and receive assistance with any part of the absentee process.

When visiting the Absentee Office, please bring your valid government issued photo ID, wear a face covering over the nose and mouth is strongly encouraged, and please maintain a distance of six feet

A&M Professor Granted Chance to Study Papers of Literary Icon

An Alabama A&M University assistant professor of English has been awarded a fellowship to study the papers and related archives of a noted African-American literary figure.

Dr. Charlotte Teague was awarded the Emory University Rose Library's 2020-2021 Leonard and Louise Riggio Fellowship Award to study in the Alice Walker papers and related archives. Emory is the exclusive home to Walker's archives, and the collection consists of the literary and personal papers of Walker from around 1930 to 2015.

After competing with applicants throughout the country, Teague won the award with her insightful research on matrilineal



dysfunction. Her research focuses on "motherhood in African-American contexts using spatiality and an ethnographic lens connected to womanist theory."

Although Teague's research also features Toni Morrison and Tayari Jones, at the center of her studies is Walker, along with her Pulitzer Prize-winning novel *The Color Purple*.

A two-time AAMU graduate from a family of Bulldogs, Dr. Teague also holds degrees from the University of Alabama in Huntsville and Morgan State University in Baltimore, Md.

She has been teaching at AAMU for 16 years. Her areas of specialization are technical and professional writing, African-American women writers, feminism/womanism, and protest literature.

Genesis 41:50-52

The "blessings" of God are too often presented in a kind of "vending-machine fashion that leaves much of the truth about them out of the discussion. We here statements like, "God gives double for our trouble" while invoking the Job's story as the example, but not including that Job had to forgive his friends for

the pain that they inflicted upon him during his time of "suffering." Even with the life of Jesus, we see that it was "after" His time in the wilderness that the "angels" appeared and ministered to Him. With Joseph, Job and Jesus, the common denominator is "suffering." The two sons that Joseph was blessed with were given names that were reminders of what



God did for him during his time of suffering. Manasseh meant "God has caused me to forget." Ephraim's name means "fruitful." This was not just about the *lavishness* of the fruitfulness, but also the *location* of it; "in the land of my affliction"

Washington in One Minute



Here are the happenings in Washington, D.C., this week:

As of Monday, the Senate was in session and the House was out. Having debated all weekend, the full Senate voted Monday night on the nomination of Judge Amy Coney Barrett to join the Supreme Court.

House Speaker Pelosi and Treasury Secretary Mnuchin have continued talks to reach a deal on a roughly \$1.9 billion coronavirus relief bill and, over the weekend, White House Chief of Staff Mark Meadows said he had a commitment from Senate Majority Leader McConnell to bring the relief bill to the floor if negotiations conclude successfully.

President Trump this week had campaign rallies in Pennsylvania on Monday and Michigan, Wisconsin, and Nebraska on Tuesday.

On Tuesday, former Vice President Biden was in Georgia for campaign events, and key Democratic surrogate former President Obama was in Florida.

According to the Nielsen Company, the second (and final) Donald Trump vs. Joe Biden presidential debate earned only 63 million total viewers across 15 networks, which is 10.1 million fewer viewers than their first debate,

which drew 73.1 million viewers. It also had fewer viewers than each of the 2016 presidential debates.

The Supreme Court will have a busy week, first welcoming its new Justice Amy Coney Barrett after she was approved as expected by the Senate on Monday, and then turning to 2 urgent appeals from the Republican Party in Pennsylvania and North Carolina seeking rulings from the court pertaining to the counting of mail-in election ballots.

The Pennsylvania GOP would like the court to rule on the merits of a state court ruling that allows ballots to be counted that are received up to three days after election day (last week the Supreme Court had allowed the 3-day rule to stand in response to a GOP request to put the ruling on hold – but now the GOP expects the addition of Justice Barrett to make a difference in how the court will rule).

In North Carolina, the GOP wants the court to block an extension of the deadline for absentee ballots for up to 9 days after the election.

On Wednesday at 10 am EDT, three giants of the tech world, Twitter's Jack Dorsey, Facebook's Mark Zuckerberg, and Alphabet/Google's Sundar Pichai, testified remotely

before the Senate Commerce Committee on the topic of whether social media platforms do enough to stop the spread of misinformation and whether the sweeping immunity granted by Section 230 of the Communications Decency Act enables "Big Tech bad behavior."

In related news, last

Thursday the Senate Judiciary Committee voted to subpoena Zuckerberg and Dorsey for a separate hearing to testify on their companies' alleged censorship of a New York Post story about emails allegedly found on Hunter Biden's laptop and other election-related content moderation policies.

Huntsville Mourns Recent Death of Mayor's 'Best Friend'

The Huntsville community mourned the death of Mayor Tommy Battle's wife and best friend, Eula Catherine Sammons Battle.

Eula was born in Huntsville, Ala., on Sept. 29, 1955, to Dr. Robert A. Sammons and his wife, Calvert Sammons. The second youngest of five children, Eula loved her hometown and joyfully spent her life giving back to her community.

A 1973 graduate of Huntsville High, Eula earned a degree in elementary education from Wesleyan College, and soon after graduation, began a successful 31-year career as a schoolteacher. After her first year of teaching in Conyers, Ga., Eula returned home to teach kindergarten in the Madison County School System. In 2000, she was named Madison County Teacher of the Year for her outstanding service and dedication.

Education remained a passion for Eula throughout her life. In 2010, when the state legislature severely cut the

education budget, eliminating a \$550 stipend for teachers to supply their classrooms, Eula took action. She co-founded Free 2 Teach, a non-profit that supplies free school materials for local teachers. Free 2 Teach has distributed more than \$7 million in supplies and materials to Huntsville-area teachers.

A devoted mother, Eula was exceptionally proud of her son, Drew, in whom she inspired her values of faith, responsibility, and service. She cherished being part of Drew's journey from son to husband and father and loved watching him parent his two young sons.

She was honored by the Women's Economic Development Council Foundation in 2014, received the DAR Founders Medal for Educa-

tion in 2019, and received the 2020 Boy Scouts Whitney M. Young Community Service Award. In 2019 Athens State University established the Eula S. Battle education scholarship so she could have a hand in developing

future teachers.

Eula is survived by her husband, Tommy Battle; their son, Drew Battle and his wife, Lauren; grandsons, George and Benjamin; and a host of other relatives and friends.

Forecasting: When, why will Trump lose his re-election bid?

"Share each other's burdens, and in this way obey the law of Christ. If you think you are too important to help someone, you are only fooling yourself. You are not that important."

Here, the Apostle Paul stressed showing empathy to fellow countrymen. To learn from one's own pain and suffering should be a humbling blessing from God.

President Trump has not learned from his (alleged) October 3rd COVID-19 hospitalization to empathize and share fellow Americans' C-19 burden.

This missed opportunity will more than anything else kill his re-election bid.



"A Blessing from God" - Really?

Trump declared his experience as "a blessing from God," and I "learned a lot."

Yes, God weighs and customizes each trial that He allows, to teach us valuable lessons. Trump's learning is not evidenced, yet.

Given his platform, he could've championed the millions of fellow Americans still suffering - either as C-19 victims' relatives, healthcare providers or associates.

And rather than be Comforter-in-Chief, he chooses to devalue the ordeal, distancing himself even further from them and their pain.

However and more recently, there has been a better example - that is, the way we saw it.

"The Way We Saw It (Presidential Leadership)"

"The Way I See It" documentary, <https://bit.ly/37xeNwA> featured President Obama's visit with families victimized by the 2012 Sandy Hook Elementary School massacre.

Victimized father David Wheeler offered, "There's no substitute for empathy, a foundational relationship between human beings. And to know that the guy who's running the show cares enough not (just) to come and visit, but to let you know that he cares about you, . . . your wife, . . . your nine-year old kid.

"We are so good at dismissing the people that we elect to serve us; we're so good at turning them into things that aren't people. And we have to be very careful about that.

"Because when we do that, then you get the elected officials you deserve."

Election Day should be proof.

OP-ED: District 6 Deserves Consistent Leadership

In October 2017, the Madison County District 6 Commissioner died unexpectedly. Governor Kay Ivey, a Republican, appointed JesHenry F. Malone, a life-long Democrat, as the successor. She was under no legal obligation to appoint someone of the same party as the deceased commissioner; but she chose to do the right thing and appoint someone who shared the same values as the commissioner the community had re-elected in 2016. No one plans to die, especially not a politician. However, Governor Ivey demonstrated to me and others that she put the interest of the local community above her political gain. She could have appointed someone from her own Republican party to

succeed our commissioner following his untimely demise. I am certain that the Madison County Republican Committee would have enjoyed adding another elected (appointed) official to their ranks. I am also sure that Governor Ivey received some push back for appointing a life-long Democrat to this vacancy.

Since he assumed office in March 2018, I have watched Commissioner Malone as he learned and maneuvered the ropes of our County Commission. He has done well. Commissioner Malone has delivered for District 6. His leadership style does differ from our former commissioner, but he is a strong and effective leader. Our former commissioner championed social service-related

initiatives and programs, and while those are good efforts, that is not the role of a county commissioner in Alabama. Although Commissioner Malone has retained some of the programs established by our former commissioner and expanded others, he has focused in on the primary functions of this governmental role that has yielded some of the best results for District 6. There are new garbage trucks, buses and freshly paved roads in our community. I hadn't seen some streets in District 6 paved since I was a child – it was long overdue. In my opinion, Commissioner Malone's single best

accomplishment is the new Madison County Service Center being built on the Parkway at Oakwood Avenue. This \$12M dollar facility is the first new economic development project in North Huntsville that I have seen since the Toyota Plant opened. This is why I am disheartened that our community has not appreciated the full value of Commissioner Malone's efforts.

This is not the time to make a change in our leadership. Commissioner Malone is making strong strides to advance our community. He is working well with our commission and we are starting to see that fruit here in District 6. Can you recall what substantive projects and programs, not social services, that our previous

two commissioners gave us? A community garden is nice, but I can buy my own vegetables. I need a freshly paved road and a safe bridge to drive on to get around the community.

I have watched this entire situation surrounding this Confederate Monument at the Madison County Courthouse. The monument didn't just appear following the death of George Floyd; it has been there! While I applaud the efforts of some of the local black politicians and community activists, where have you been!? Calling for the removal of a monument in the height of civil tensions is just mere political gain. However, Commissioner Malone stood outside the courthouse and during commission meeting and told us

that he would work to get that monument removed. Collectively with the entire commission, the owners of the monument, Commissioner Malone convinced his fellow commissioners to join him in removing the confederate monument from our courthouse. Our previous two commissioners didn't even try to remove it, and we re-elected them. Commissioner Malone led the efforts to get it done and now we want to change commissioners? We need consistent leadership in District 6. Join me on November 3rd and write-in and bubble Jes Malone. We still need him in District 6.
